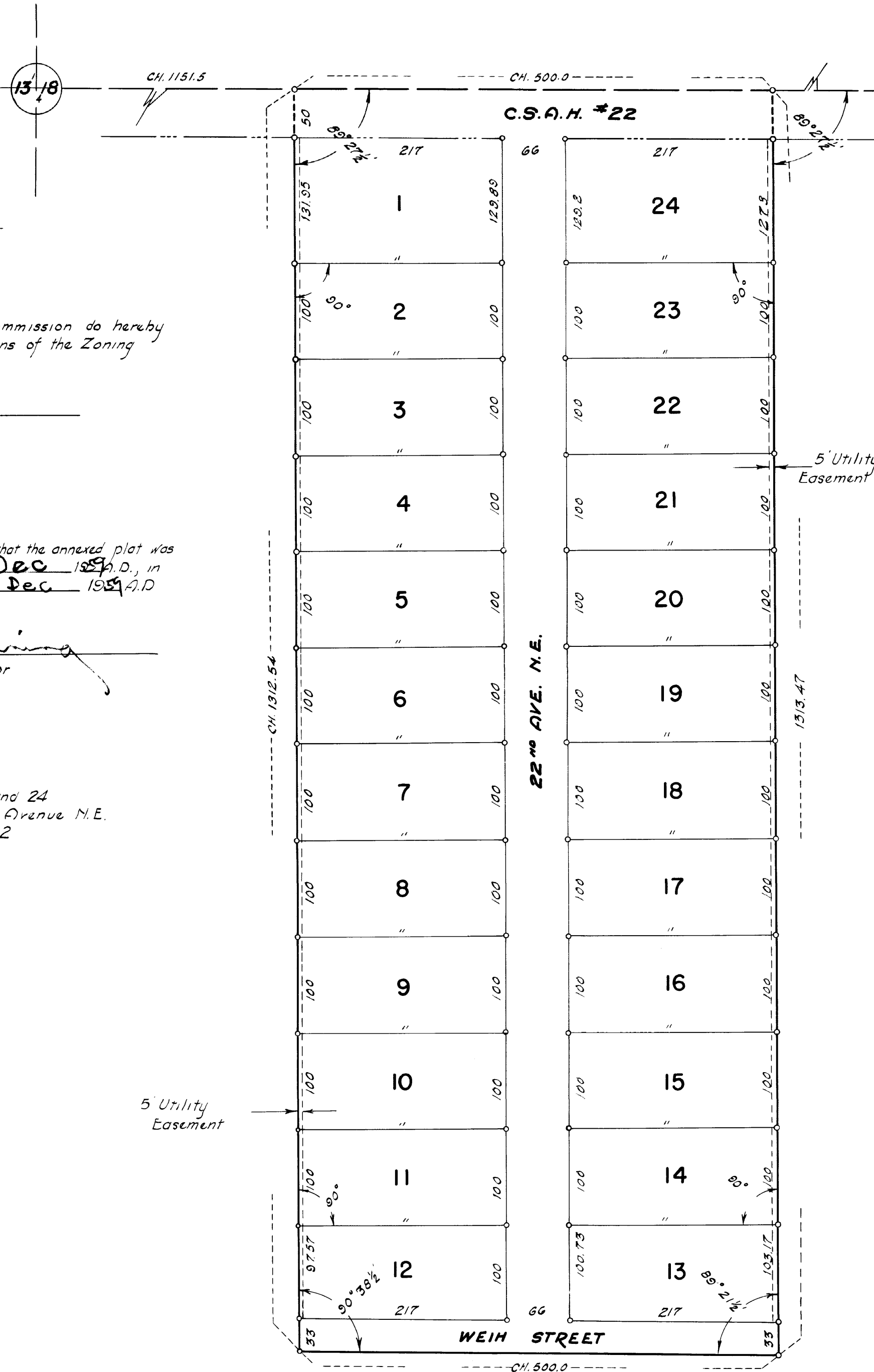

SURVEYOR'S CERTIFICATE

K.M. McGhie, Registered Civil Engineer & Land Surveyor, do hereby certify that at the request of **ROXIE L. WEIH**, I have surveyed and platted into lots, streets and easements as shown on the accompanying plat on which this certificate is written and which shall be known and designated as **WEIH SUBDIVISION**, the following described tract of land:

A part of the North half of the Southwest quarter of Section 18, Township 107 North, Range 13 West described by metes and bounds as follows:
Commencing at the Northwest corner of the Southwest Quarter of said section, thence easterly along the North line of said quarter for a distance of 1151.5 feet for a place of beginning, thence continue along said north line for a distance of 500 feet, thence southerly parallel to the West line of said quarter section for a distance of 1313.47 feet, thence westerly at a deflection angle of 90 degrees 38 1/2 minutes right for a distance of 500.0 feet, thence northerly parallel to the West line of said quarter for a distance of 1312.54 feet to the place of beginning.

And I further certify that the accompanying plat is a correct record and representation of the survey, that all distances are correctly shown in feet and decimal of feet, the monuments for the guidance of future surveys as shown thus (o) have been placed on the ground, that the outside boundaries are correctly shown on the plat, that there are no wetlands thereon; and that said tract has not been previously platted.
