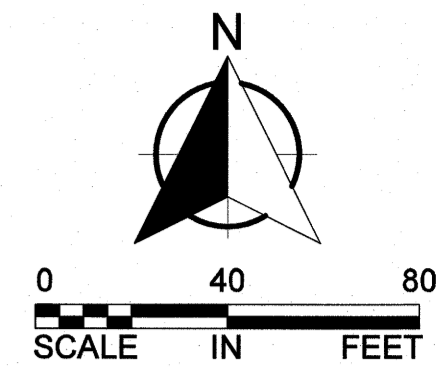


CRIMSON RIDGE FIFTH SUBDIVISION
