

NORTHGATE FOURTH ADDITION

SURVEYOR'S CERTIFICATE

I, K. M. McGhee, Registered Civil Engineer and Land Surveyor, do hereby certify that at the request of CHARLES R. HUTCHINSON, I have surveyed and platted into lots, blocks, and easements as shown on the accompanying plat on which this certificate is written, and shall be known and designated as NORTHGATE FOURTH ADDITION, the following described tract of lands:

A Port of the Northwest quarter of Section 27 Township 107 North, Range 14 West described by metes and bounds as follows:

Beginning at a point where the west line of 21st Avenue Northwest intersects the north line of 20th Street Northwest in NORTHGATE THIRD ADDITION to the City of Rochester, thence North along the west line of said 21st Avenue a distance of 9.8 feet to the beginning of a curve of 605.96 foot radius and whose delta angle is 12 degrees 45 minutes to the right, thence Northeasterly along said curve a distance of 135.37 feet to the point of tangent of said curve, thence Northeasterly tangent to said curve a distance of 173.80 feet to a point on a curve whose tangent is at a deflection angle of 87 degrees 42 minutes 00 seconds to the left from the previous described course and whose radius is 914.47 feet and whose delta angle is 8 degrees 12 minutes 00 seconds to the right, thence Northwesterly along said curve a distance of 130.88 feet to the point of tangent of said curve, thence Southwesterly at a deflection angle of 100 degrees 30 minutes 00 seconds to the left from said tangent a distance of 270.95 feet, thence South at a deflection angle of 12 degrees 45 minutes to the left a distance of 92.95 feet, thence East at a deflection angle of 89 degrees 59 minutes to the left a distance of 130.0 feet to the place of beginning.

Also beginning at the northwest corner of 20th Avenue and 22nd Street Northwest in said Addition, thence Southwesterly along the northerly line of 22nd Street a distance of 47.2 feet to the beginning of a curve to the right of 848.47 foot radius and whose delta angle is 42 degrees 46 minutes 00 seconds to the right, thence Westerly along said curve a distance of 633.3 feet to the point of tangent of said curve, thence Northwesterly at a deflection angle of 90 degrees to the right from said tangent a distance of 115.0 feet thence Southeasterly at a deflection angle of 85 degrees 47 minutes 15 seconds to the right a distance of 107.10 feet, thence Southerly at a deflection angle of 8 degrees 22 minutes 25 seconds to the left a distance of 107.10 feet, thence Easterly at a deflection angle of 8 degrees 22 minutes 25 seconds to the left a distance of 107.10 feet, thence Northeasterly at a deflection angle of 8 degrees 22 minutes 25 seconds to the left a distance of 107.10 feet, thence Northeasterly at a deflection angle of 8 degrees 10 minutes 00 seconds to the left a distance of 107.10 feet, thence Northeasterly at a deflection angle of 50 degrees 16 minutes 00 seconds to the left a distance of 58.86 feet to a point on the westerly line of 20th Avenue Northwest, thence Southeasterly at a right angle a distance of 115.0 feet to the place of beginning.

And I further certify that the said plat is a true and correct record of the survey and that all distances are correctly shown in feet and decimals of feet, that monuments (iron pins) for the guidance of future surveys have been placed in the ground as shown thus (o), that the outside boundaries are correctly shown on the plat, and that there are no wet lands thereon, and said land has not been previously platted.


