

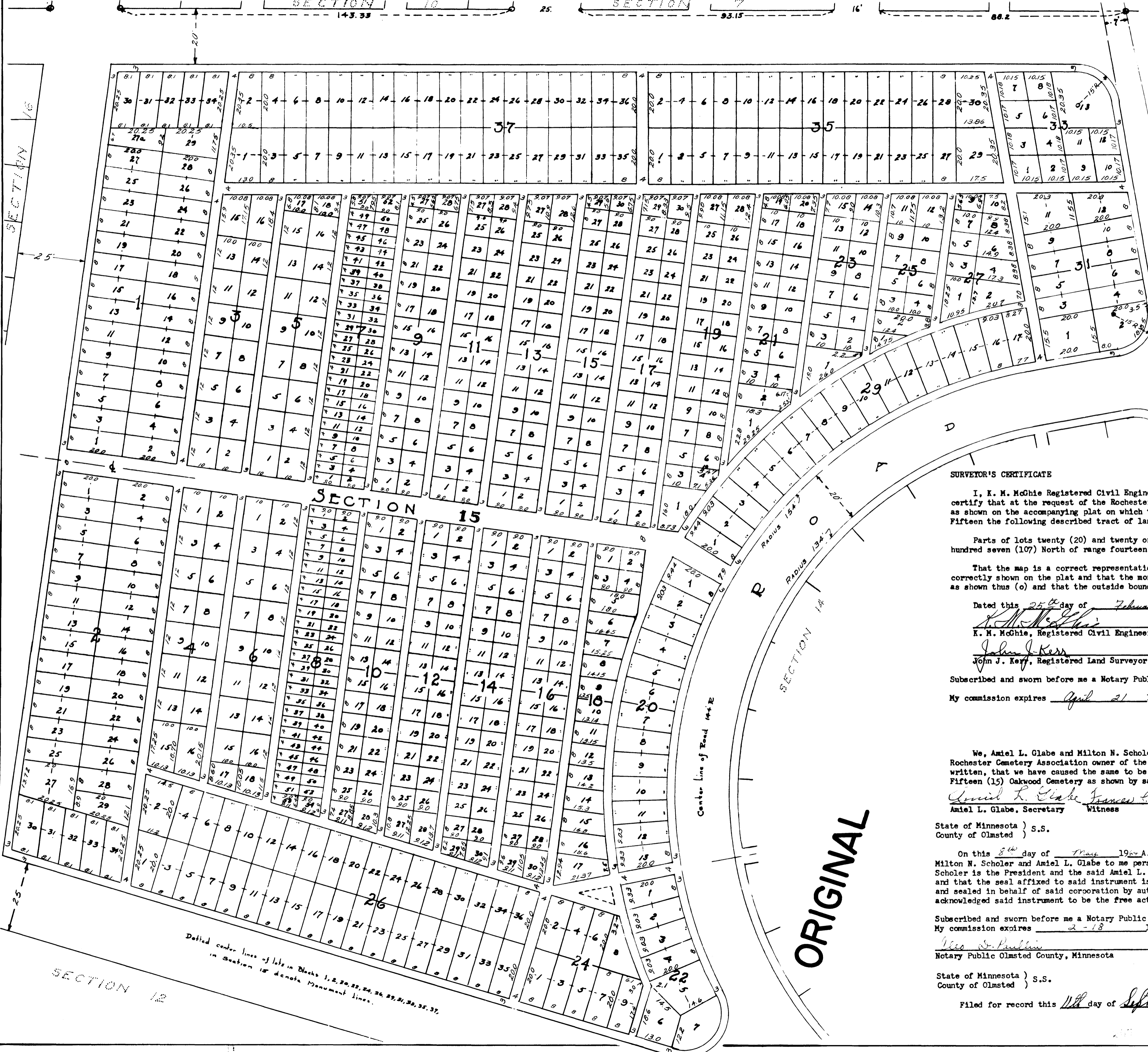
OAKWOOD CEMETERY

SURVEYOR'S CERTIFICATE

I, K. M. McGhie Registered Civil Engineer and Land Surveyor and I, John J.
