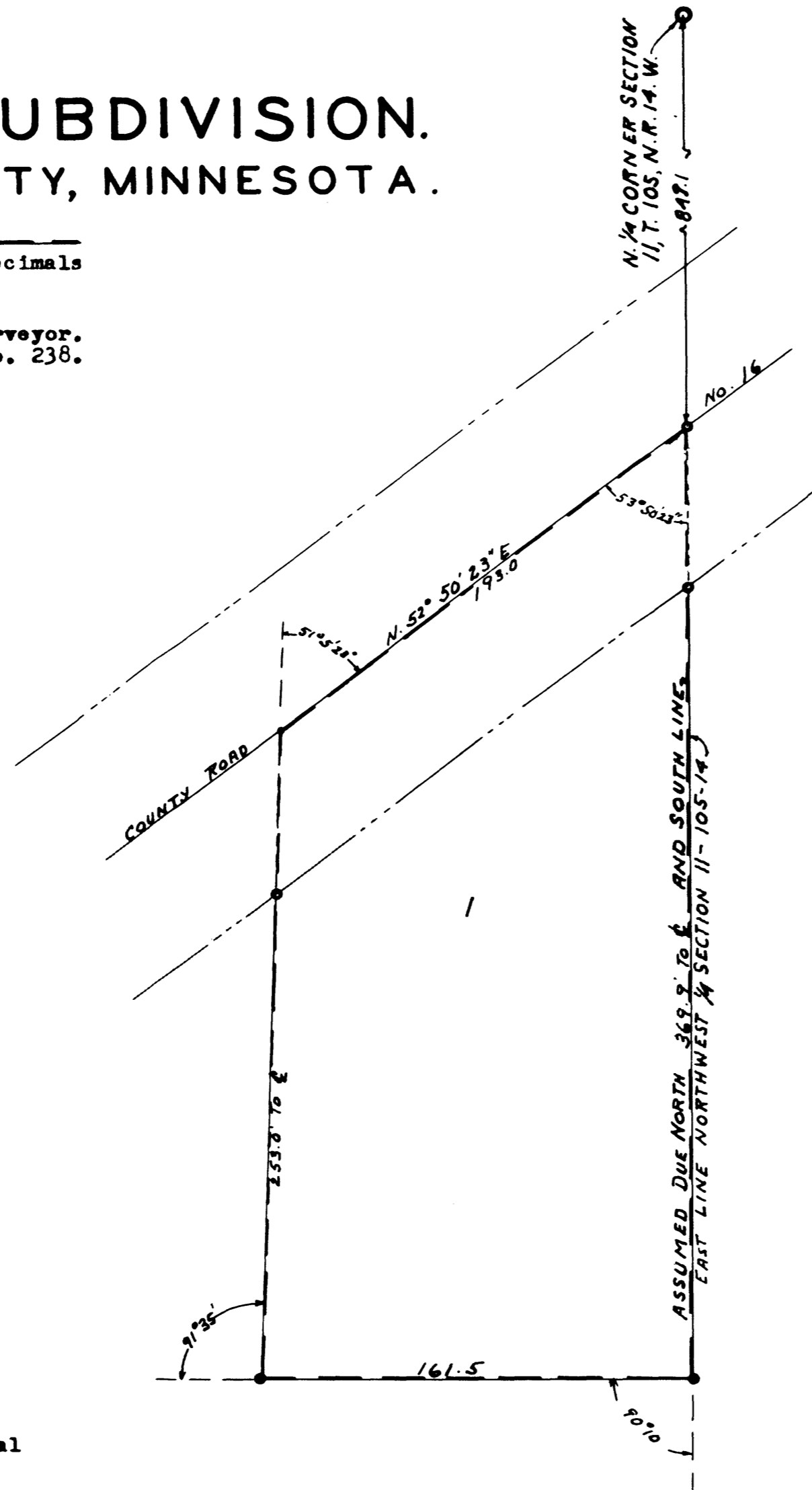


# LILJA'S SUBDIVISION. OLMSTED COUNTY, MINNESOTA.
