

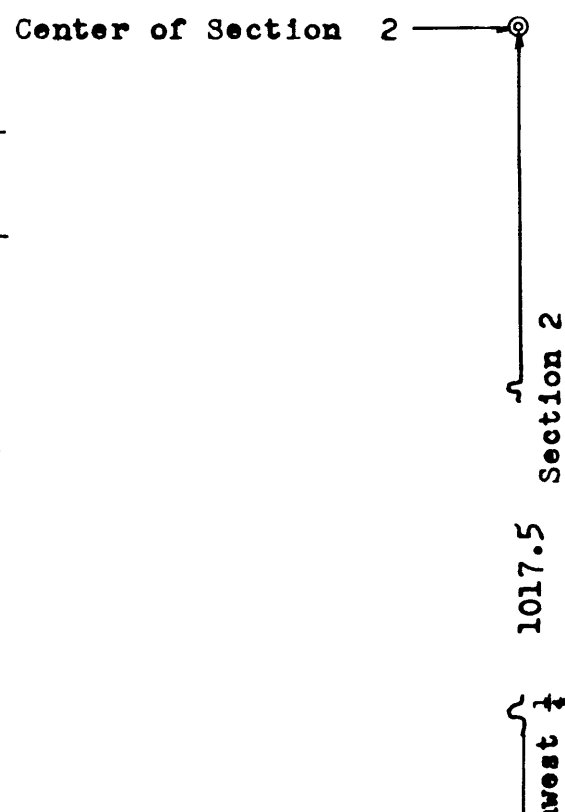


# AIRPORT VIEW. OLMSTED COUNTY, MINNESOTA.

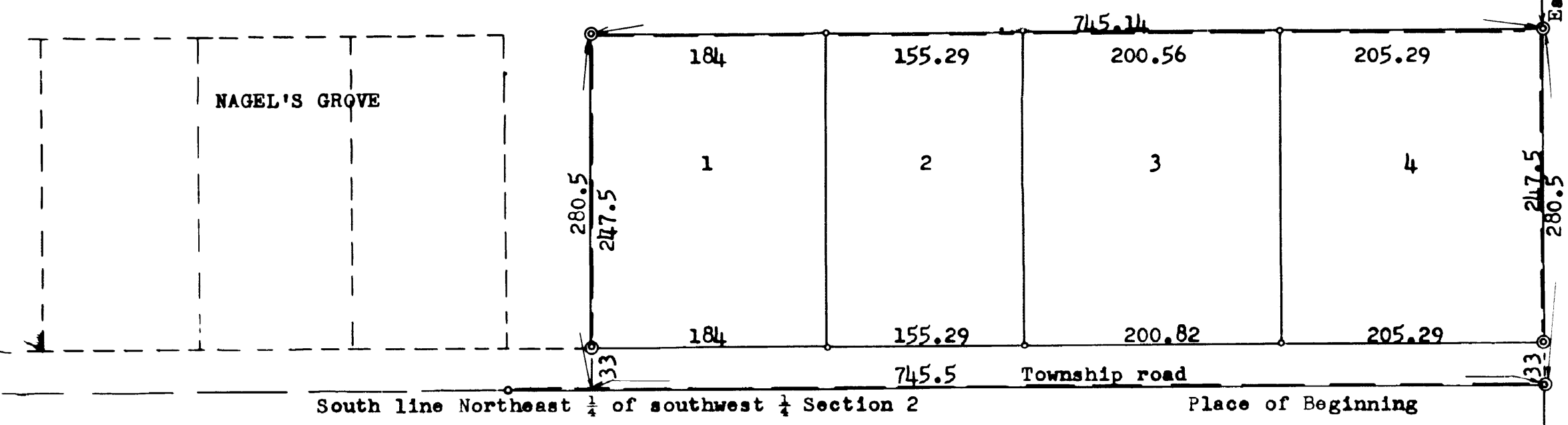
