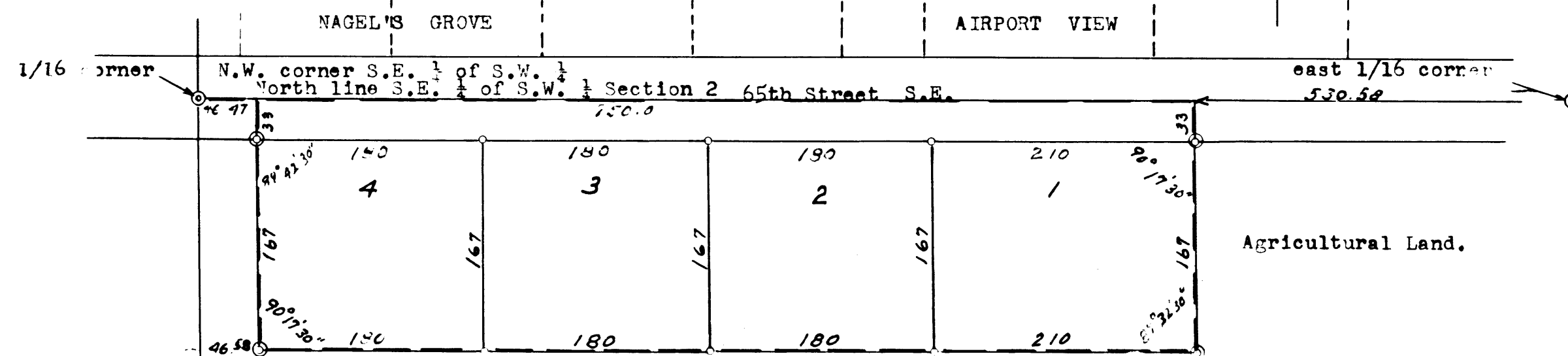
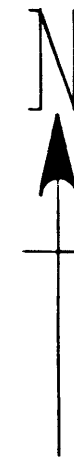


PORT RIDGE. OLMSTED COUNTY, MINNESOTA.
