

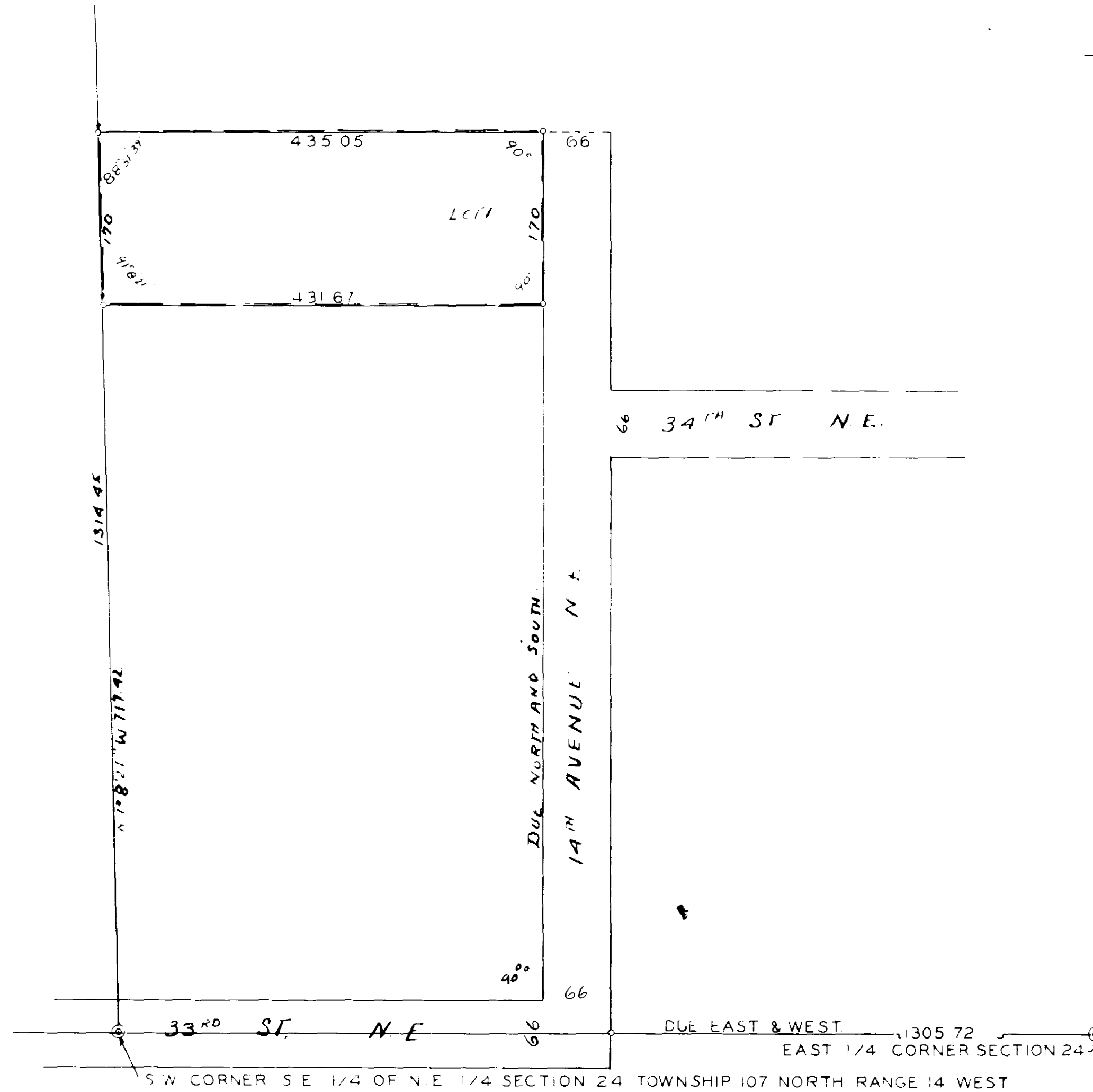


OFFICIAL PLAT
