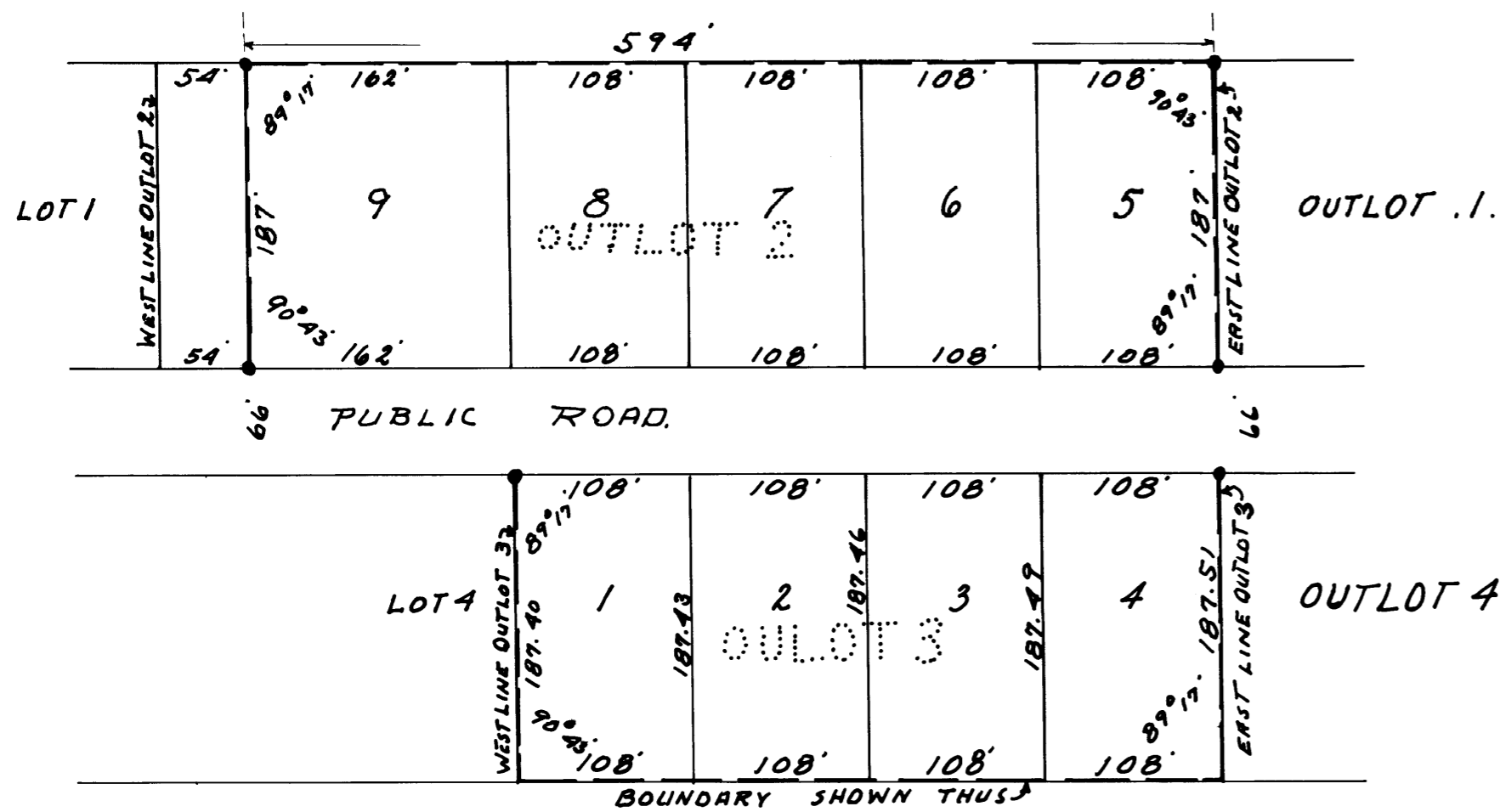


NEILL'S REPLAT.
