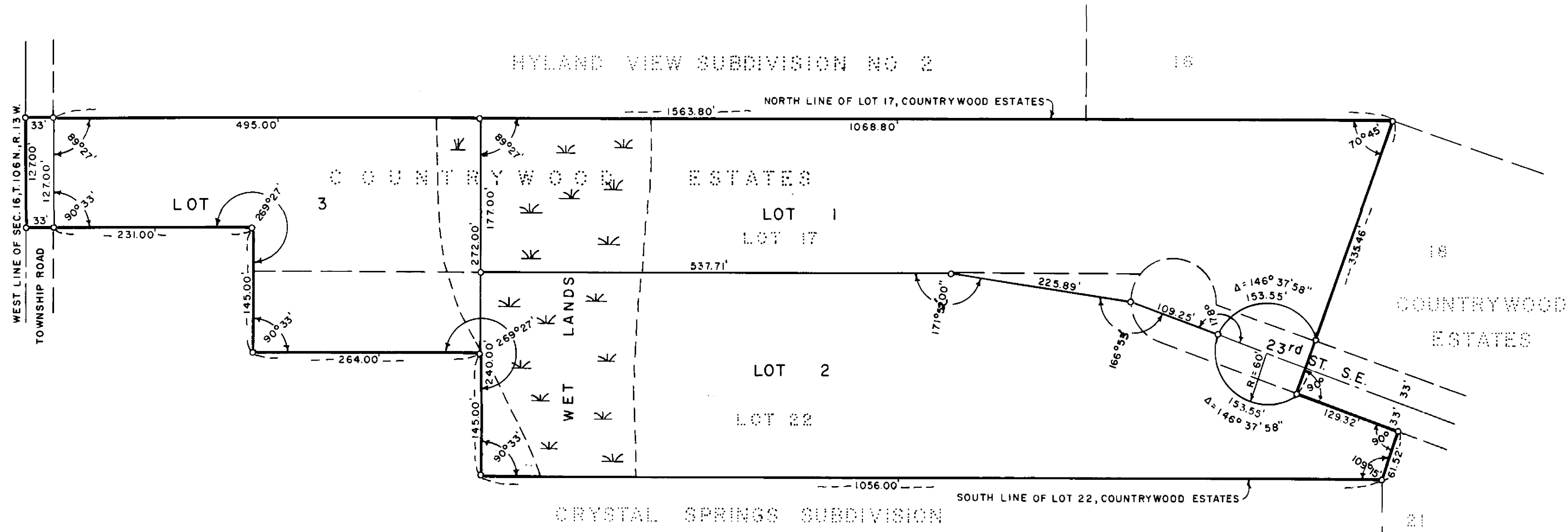


REPLAT OF LOTS 17 AND 22, COUNTRYWOOD ESTATES OLMSTED COUNTY, MINNESOTA
