

PLAT OF LEMKE SUBDIVISION

ROCHESTER, MINNESOTA SURVEYOR'S CERTIFICATE

I, K.M. McGhie, Registered Civil Engineer and Land Surveyor, do hereby certify that, at the request of George H. Lemke, I have surveyed and platted into lots and streets as shown on the accompanying plat on which this certificate is written and which shall be known and designated as LEMKE SUBDIVISION the following described tract of land: The South 873.0 feet of the East five acres of the Southeast quarter of the Southwest quarter of Section 26 Township 107 North, Range 14 West; also beginning at a point on the West line of Outlot No. 1 of Northern Addition which is 222.0 feet South of the Northwest corner of said Outlot, thence East parallel with the North line of said Outlot a distance of 116.0 feet, thence South 96.5 feet, thence West 58.0 feet, thence South to the centerline of Fourteenth Street Northwest, thence West 58 feet to the West line of Outlot No. 1, thence North to the place of beginning; also the West 200.0 feet of the North 222.0 feet of Outlot No. 1; also the West 180.0 feet of the South 2 acres of Outlot No. 2 Northern Addition; Also beginning at a point on the West line of Outlot No. 2 Northern Addition which is 23.9 feet South of the Northwest corner of said Outlot, thence South along the lot line a distance of 47.39 feet, thence East a distance of 33.0 feet, thence Northwest a distance of 57.85 feet to the place of beginning. And I further certify that the accompanying plat is a correct record and representation of the survey, that all distances are correctly shown in feet and decimals of feet, that monuments for the guidance of future surveys have been placed in the ground as shown thus \bullet and described on the plat, that the outside boundaries are correctly shown on the plat; that there are no wet lands thereon; and that said tract has not been previously platted.

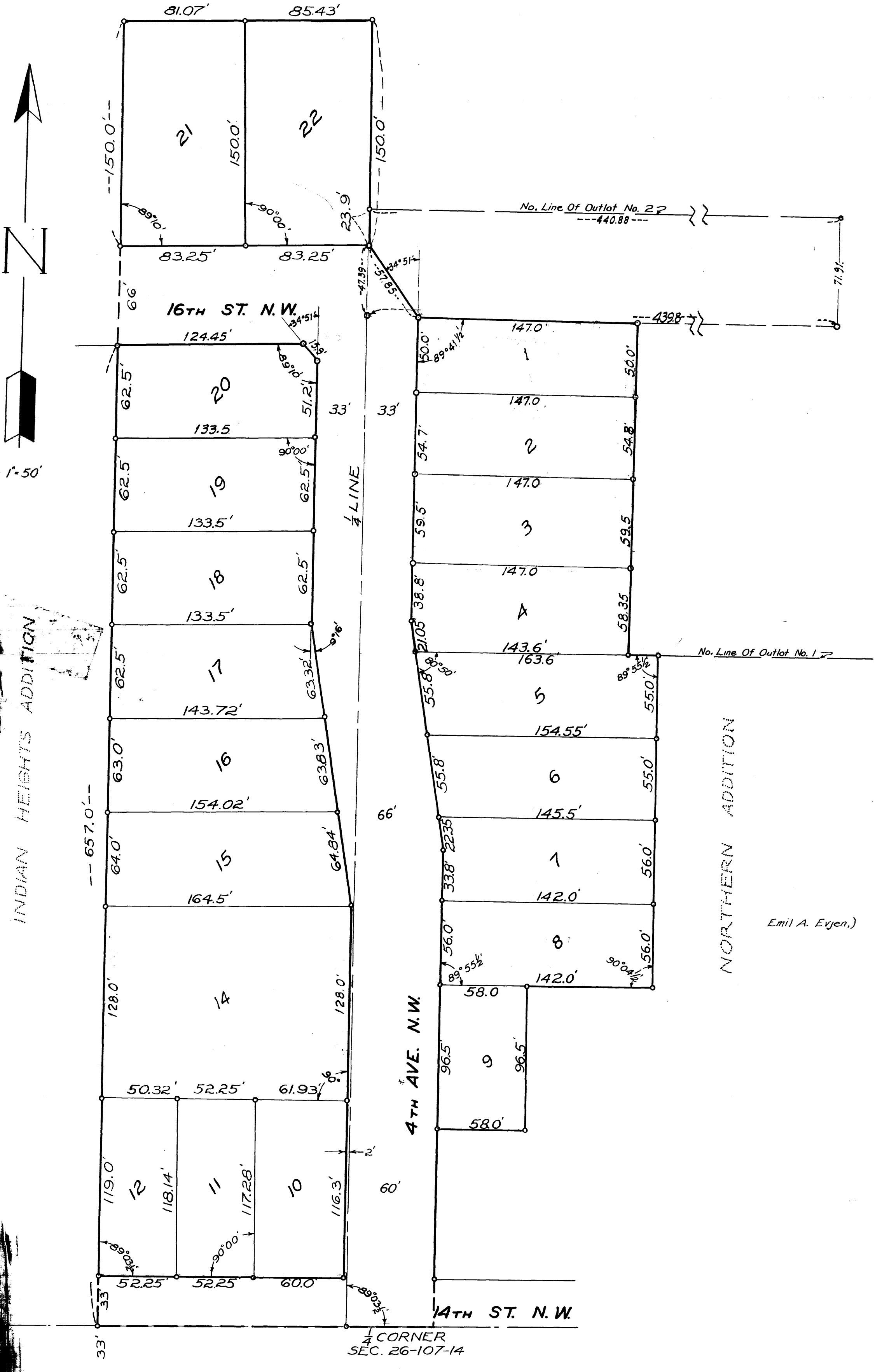
