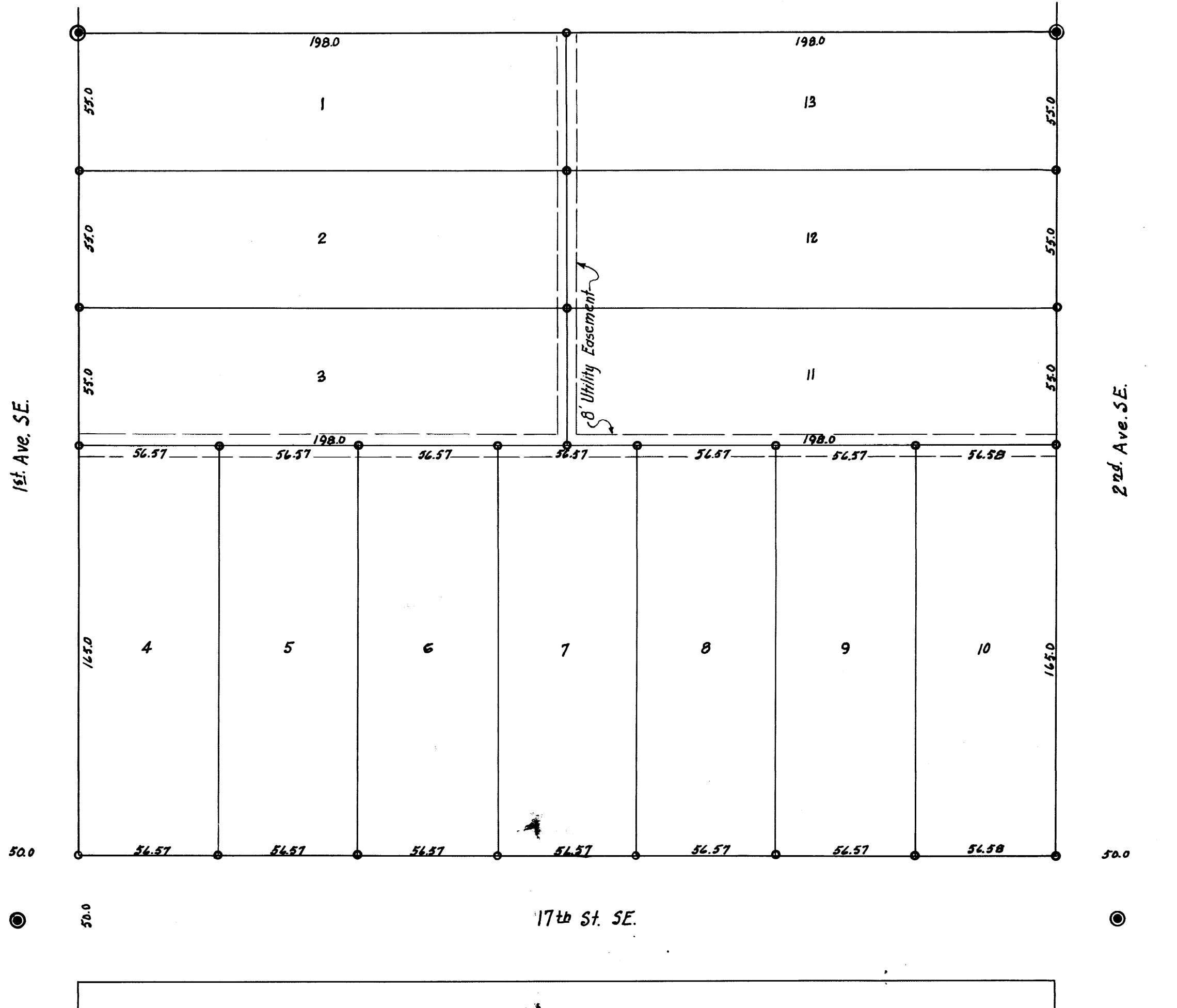


SATTRE'S REPLAT OF THE S 1/2 LOT 2 & LOTS 3-7-8-9
