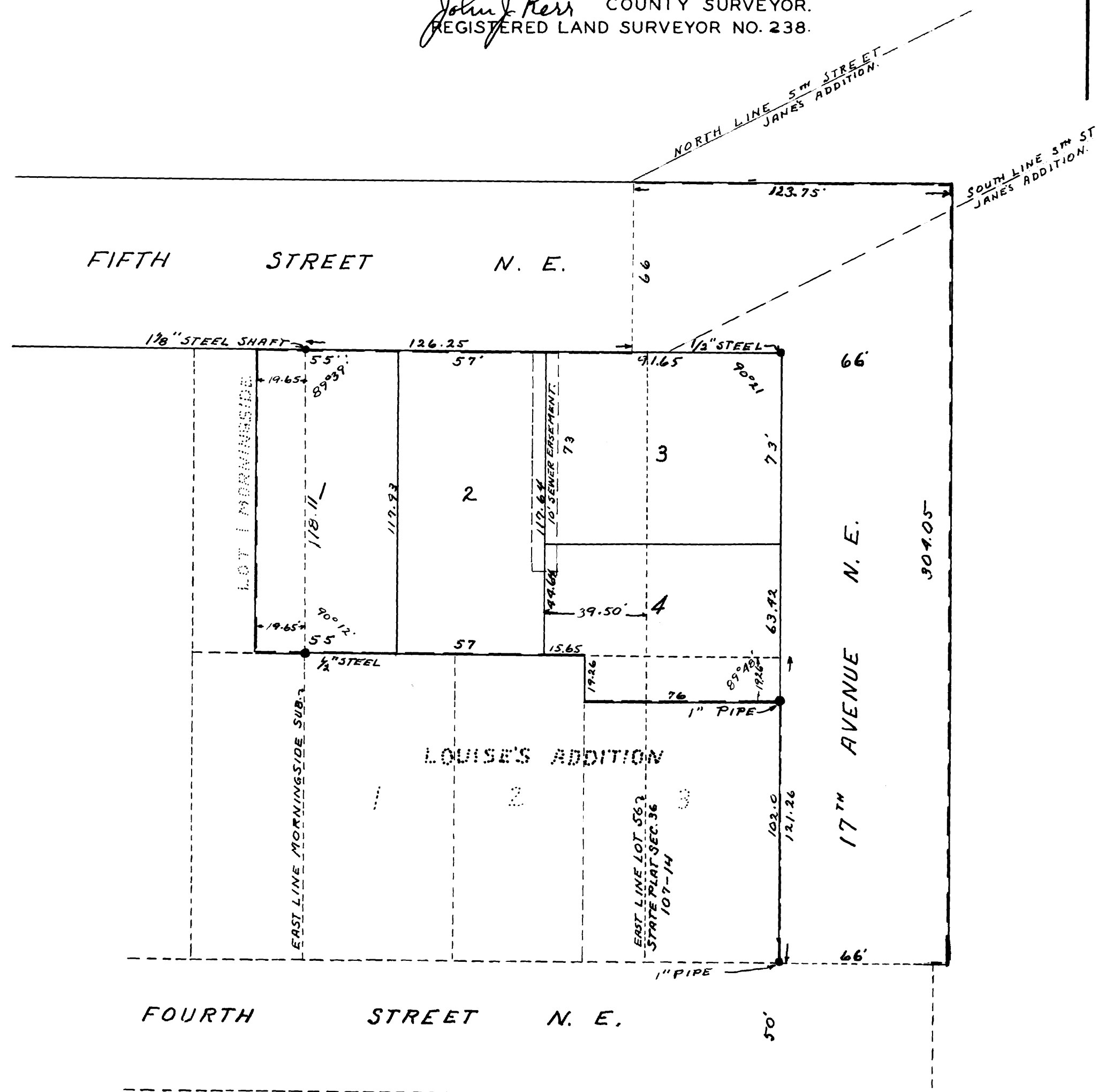


LOUISE'S SECOND ADDITION.

I, JOHN J. KERR DO HEREBY CERTIFY THAT AT THE REQUEST OF CLARENCE M. BOUTELLE AND KATHRYN BOUTELLE (HIS WIFE) OWNERS OF THE FOLLOWING DESCRIBED LANDS: THE EAST 194.5 FEET OF LOT 1 BLOCK 1 MORNINGSIDE SUBDIVISION AND THE NORTH 19.26 FEET OF LOT 3 LOUISE'S ADDITION AND COMMENCING AT THE SOUTHEAST CORNER OF LOT 3 LOUISE'S ADDITION AND RUNNING THENCE NORTH TO THE NORTHEAST CORNER THEREOF, THENCE WEST A DISTANCE OF 184 FEET TO THE NORTHWEST CORNER OF LOT 1 LOUISE'S ADDITION, THENCE NORTH TO THE NORTHEAST CORNER OF LOT 1 BLOCK 1 MORNINGSIDE SUBDIVISION, THENCE EAST ALONG THE SOUTH LINE OF FIFTH STREET NORTHEAST A DISTANCE OF 126.25 FEET, THENCE NORTH 66 FEET TO THE NORTHLINE OF SAID FIFTH STREET NORTHEAST, THENCE EAST ALONG THE NORTH LINE OF FIFTH STREET NORTHEAST IF EXTENDED IN A STRAIGHT LINE A DISTANCE OF 123.75 FEET, THENCE SOUTH A DISTANCE OF 304.05 FEET, THENCE WEST A DISTANCE OF 66 FEET TO THE PLACE OF BEGINNING, I HAVE SURVEYED AND PLATTED SAID LANDS INTO LOTS, STREETS AND AVENUES SUCH SUBDIVISION TO BE KNOWN AND DESIGNATED AS "LOUISE'S SECOND ADDITION", I FURTHER CERTIFY THAT THE ACCOMPANYING PLAT IS A TRUE REPRESENTATION OF SAID SURVEY AS MADE, THAT MEASUREMENTS ARE SHOWN IN FEET AND DECIMALS OF A FOOT, THAT MONUMENTS FOR THE GUIDANCE OF FUTURE SURVEYS HAVE BEEN PLACED IN THE GROUND AT THE LOCATIONS MARKED THUS AND DESCRIBED, THAT THERE ARE NO WET LANDS THEREON, THAT SAID LANDS HAVE HERE-TO-FORE BEEN SUBDIVIDED OR PLATTED, THAT PREVIOUS SUBDIVISION LINES ARE INDICATED ON SAID PLAT AND THAT ANGLES OF ENCLOSURE ARE SHOWN.
