

## SURVEYOR'S CERTIFICATE

I have surveyed and platted into lots, blocks, and streets as shown on the accompanying plat on which this certificate is written and which shall be known and designated as KAHOUN'S ADDITION, the following described tract of land:

Commencing at the Northeast corner of the Southeast quarter of Section 17, Township 106, North of Range 13 West, running thence south 48 minutes east along the east line of said section a distance of 475.6 feet for place of beginning, running thence south 48 minutes east a distance of 559.42 feet, running thence south 89 degrees 12 minutes west a distance of 542.08 feet to the center line of Trunk Highway 52, running thence north 33 degrees 42 minutes west along the center of said Trunk Highway a distance of 484.00 feet, running thence north 67 degrees 31 minutes east a distance of 423.67 feet, running thence east a distance of 412.88 feet to the place of beginning.
