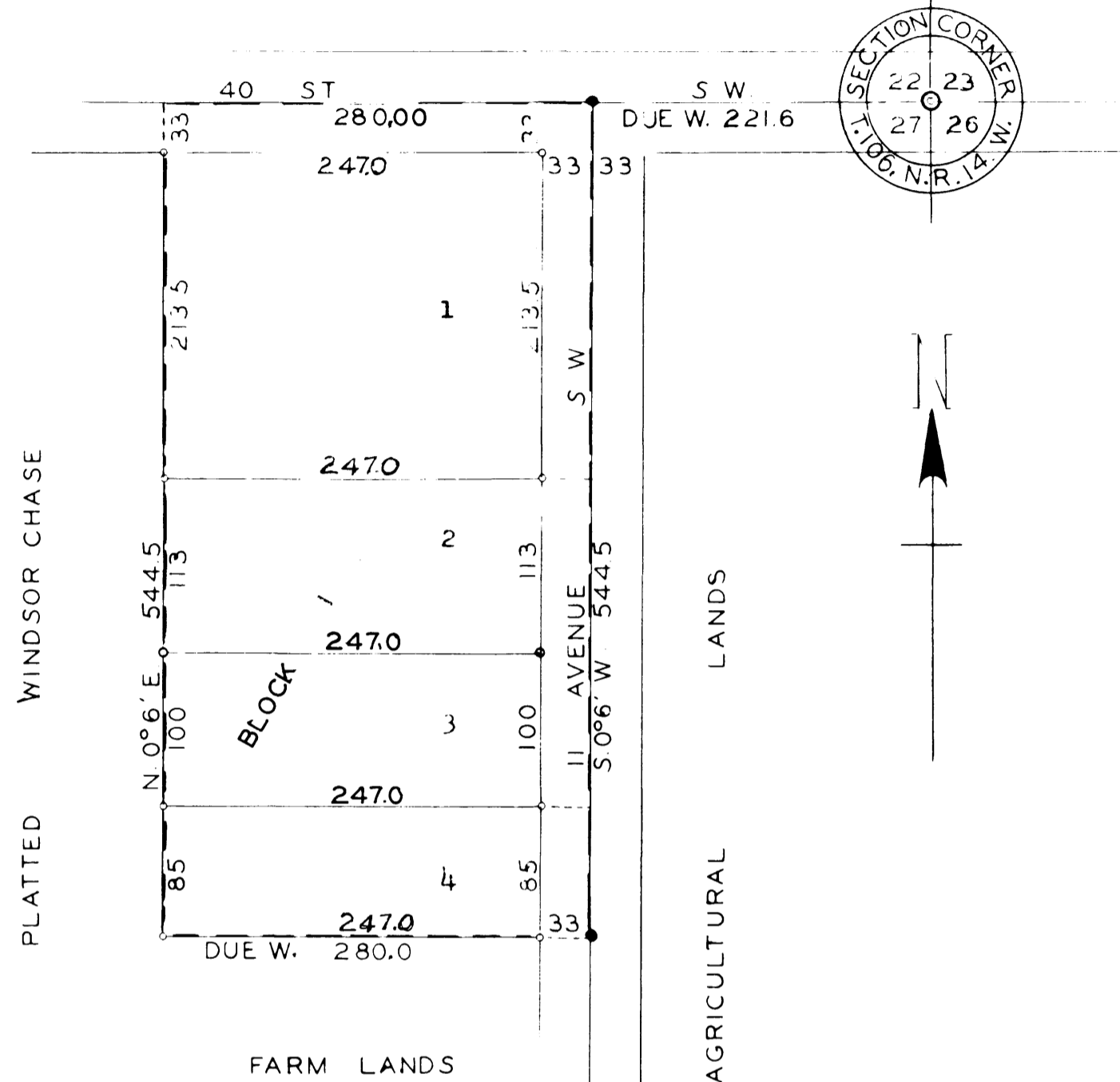


STANTON'S FIRST SUBDIVISION.
