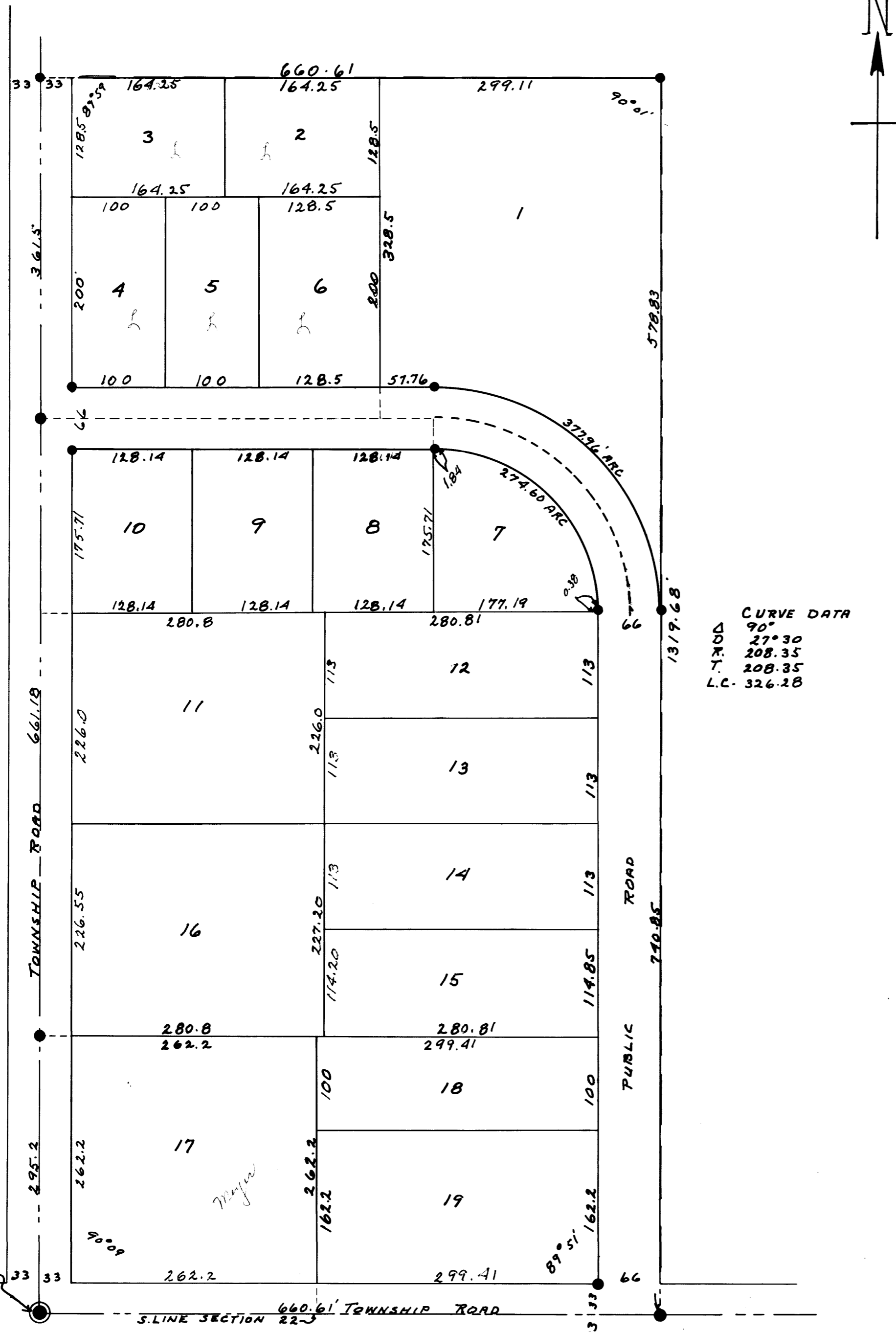


# LILLIE'S FIRST SUBDIVISION.

 I, JOHN J. KERR COUNTY SURVEYOR IN AND FOR SAID COUNTY DO HEREBY CERTIFY THAT AT THE REQUEST OF JOSEPH D. LILLIE AND MARY E. LILLIE (HIS WIFE), OWEN L. MEYER AND GLADYS J. MEYER (HIS WIFE), HAROLD A. LUTHER AND VIVIAN A. LUTHER (HIS WIFE), HARLAN G. LUTHER (SINGLE), DONALD P. CRISPIN (SINGLE), AND ROSEMARY MORGAN (SINGLE), OWNERS OF THE FOLLOWING DESCRIBED LANDS: COMMENCING AT THE SOUTHWEST CORNER OF THE SOUTHEAST 1/4 OF SECTION 22, TOWNSHIP 106, NORTH OF RANGE 14 WEST FOR THE PLACE OF BEGINNING AND RUNNING THENCE NORTH ALONG THE WEST LINE OF SAID SOUTHEAST 1/4 A DISTANCE OF 1317.88 FEET TO THE NORTHWEST CORNER OF THE SOUTH 1/2 OF SAID SOUTHEAST 1/4, THENCE EAST ALONG THE NORTH LINE OF SAID SOUTH 1/2 A DISTANCE OF 660.61 FEET, THENCE SOUTH PARALLEL WITH THE WEST LINE OF SAID SOUTHEAST 1/4 A DISTANCE OF 1319.68 FEET TO THE SOUTH LINE OF SAID SECTION, THENCE WEST ALONG THE SOUTH LINE OF SAID SECTION A DISTANCE OF 660.61 FEET TO THE PLACE OF BEGINNING, I HAVE SURVEYED AND PLATTED SAID LANDS INTO LOTS AND PUBLIC ROADS SUCH SUBDIVISION TO BE KNOWN AND DESIGNATED AS "LILLIE'S FIRST SUBDIVISION".
