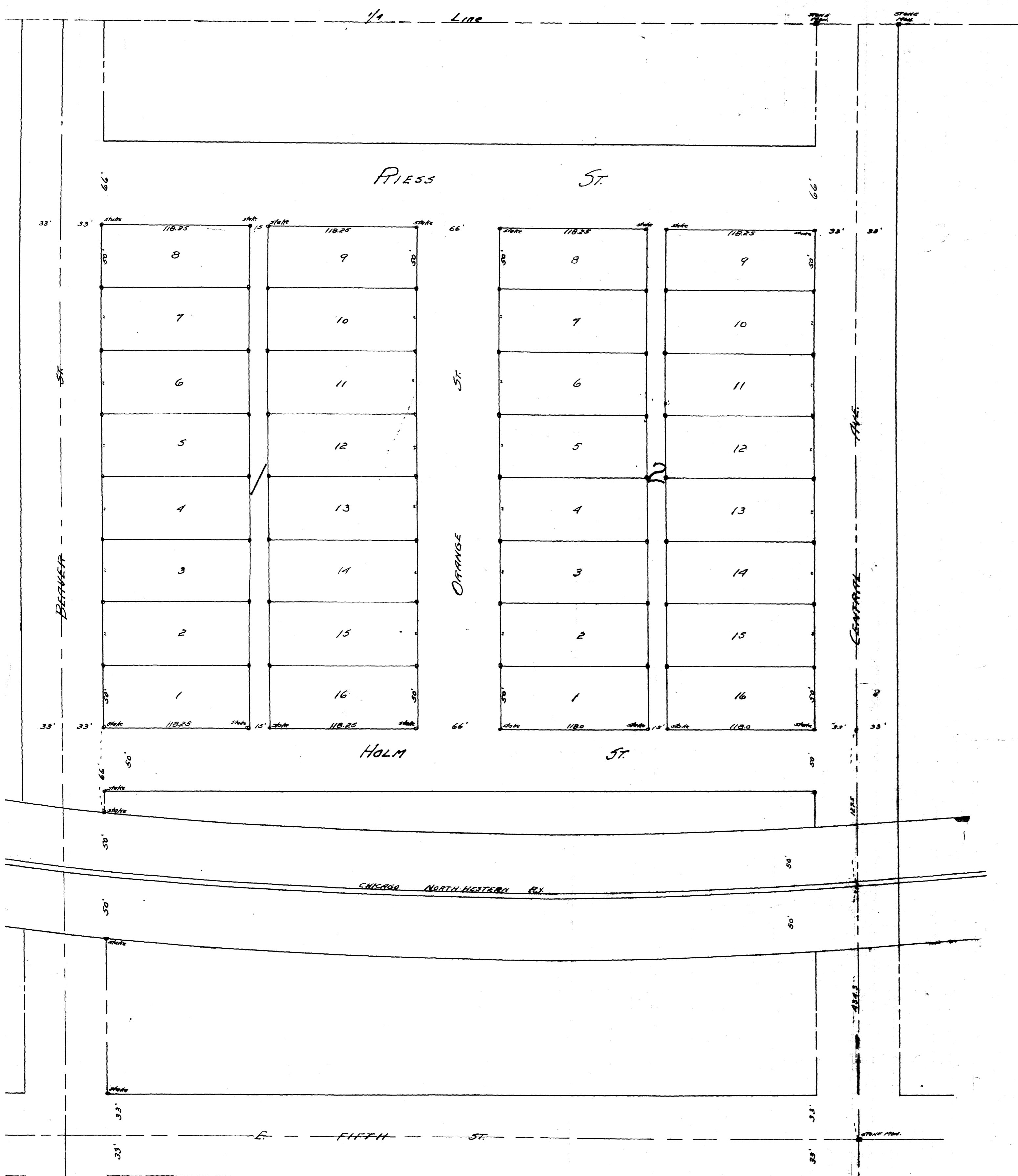
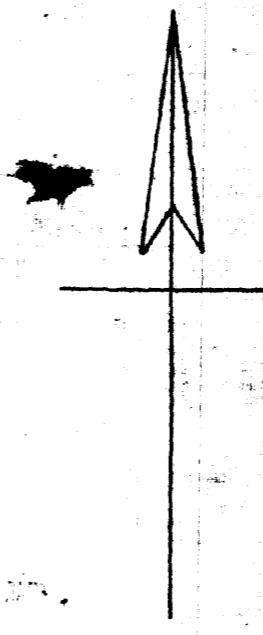


PLAT OF RIESS' SUB-DIVISION.
