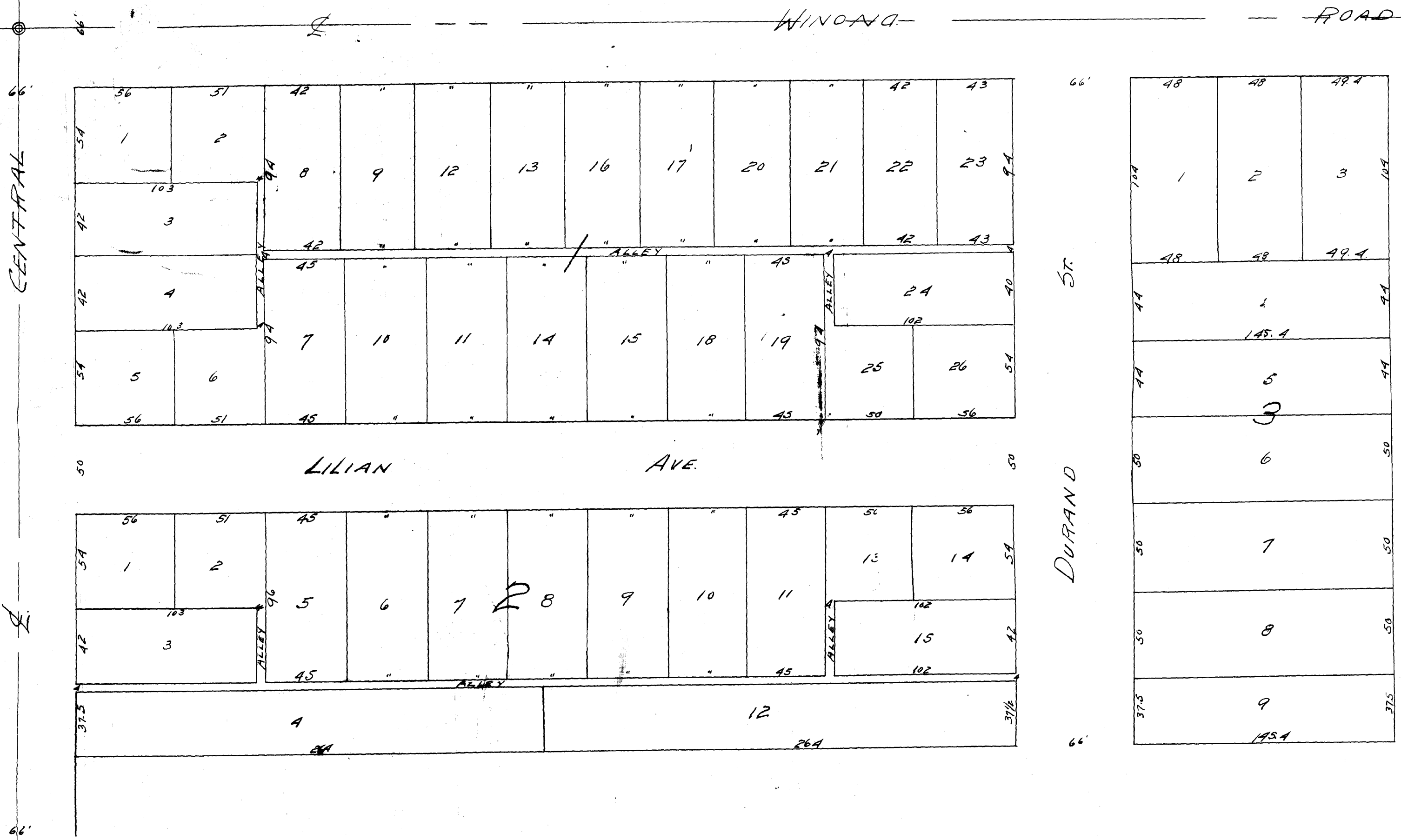


E.A. BUCK'S ADDITION.

I, J.C. Utton do hereby certify that the request of E.A. Buck & Katherine Buck his wife, owners of the following described tracts or parcels of lands, lying & being within the corporate limits of the City of Rochester, County of Olmsted, State of Minnesota to-wit: Commencing at the North West corner of the North East quarter of Section No. one (1) in Township 106, No. 14 R. 14 W. thence running East on the Section line forty six (46) rods, thirteen and two-fifths (13 2/5) feet, thence running South Twenty five (25) rods, thence running West, forty six (46) rods, thirteen and two-fifths (13 2/5) feet, thence running North Twenty five (25) rods to place of beginning, excepting & reserving for public use the North two (2) rods and the West two (2) rods of the land above described, I have surveyed and platted said tracts or parcels of land above described into Blocks, lots, streets & alleys, as an Addition to the City of Rochester, as shown on the accompanying plat; said Addition to be known & designated as E.A. Buck's Addition. I further certify that the accompanying plat is a correct representation of the survey and that all the distances are correctly shown on plat, in feet and decimals of a foot, that monuments for guidance of future surveys have been placed as shown thus @ that the outside boundary lines are correctly designated on the plat; that there are no wet lands thereon and that said tracts of land have not been heretofore platted into Blocks and lots.
