## Surveyor's Certificate

I, D.R. Williams hereby certify that at the request of Kerry E. Conley and Sadie I. Conley his wife, William H. Turner and Mamie H. Turner his wife; owners of the within described tract or parcel of land lying and being within the corporate limits of the city of Rochester, in the county of Olmsted, state of Minnesota; to wit; beginning on the south line of 9th street 22.5 feet east of the center line of John street, if extended; thence North 440.8 feet thence West 40 feet; thence North parallel with the East line of John street 60 feet; thence West 20 feet; thence North parallel with the East line of John street to the Chicago Great Western Rail Road right of way; thence North Westerly along said right of way to the West line of Section No 35; thence South on said West line of Section No 35 to the center line of 10th street, if extended; thence East on center line of 10th street to the East line of Horton street, if extended; thence South on the East line of Horton street 107.5 feet; thence East parallel with 9th street to the center line of John street, if extended; thence South on the center line of said John street to the South line of 9th street, if extended; thence East to place of beginning; I have surveyed and platted the said lands into blocks, lots, streets and alleys as laid down on the accompanying plat, under the name of "CONLEY'S ADDITION" and I further certify that the accompanying plat is a true and correct representation of said survey, that all distances are correctly shown on the plat in feet and decimals of feet, that the monuments shown thereon are in place as indicated, and that there are no wet lands thereon. 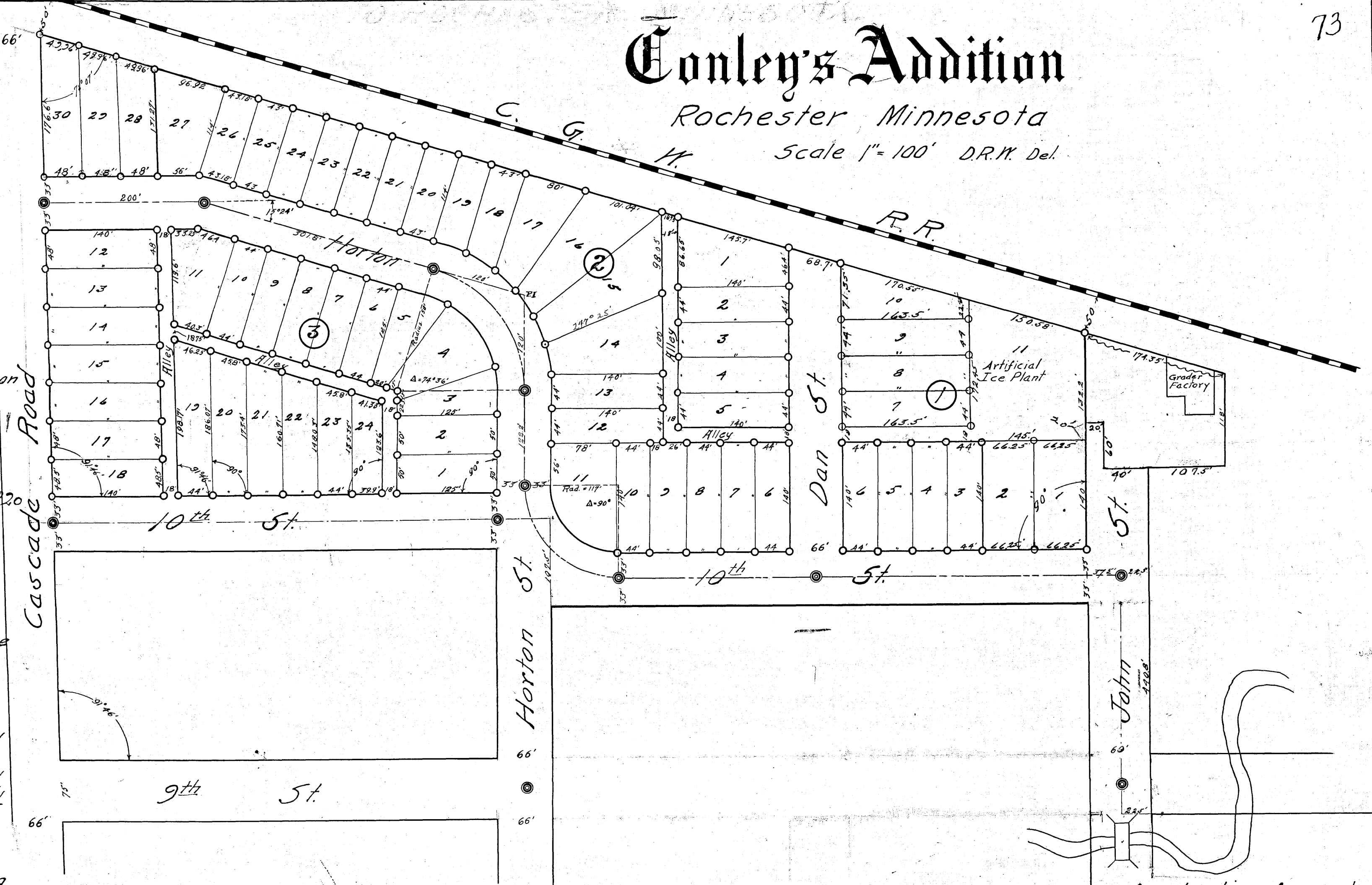
