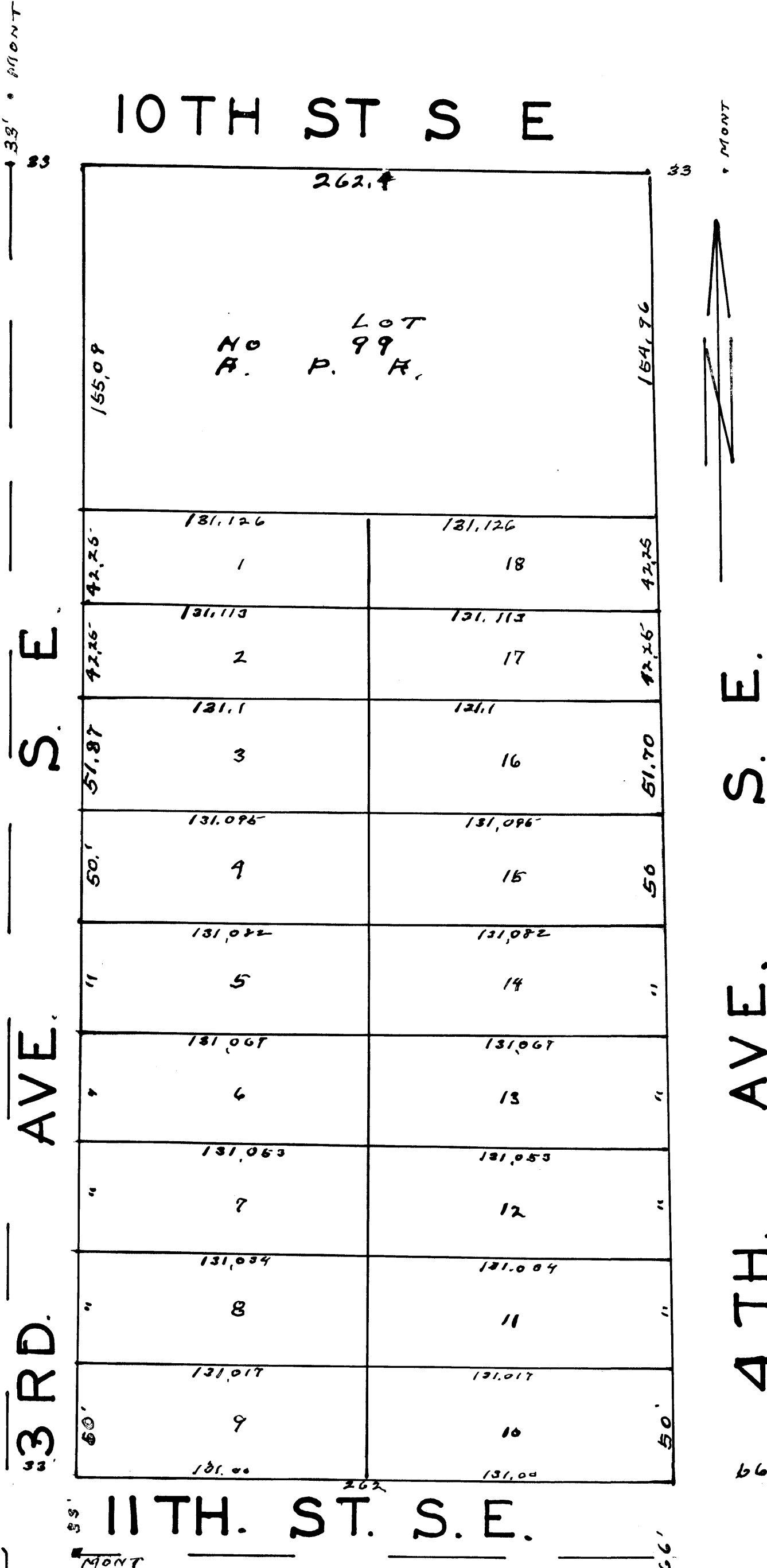


LAURA L DOMKE SUBDIVISION.

Domke and Henry Domke, her husband owners of the lands hereinafter described, surveyed and staked out into lots, all that part of Lot No. One-hundred (100), less part taken for Fourth Avenue Southeast to be known and designated as LAURA L. DOMKE SUBDIVISION, of Lot No. One-hundred (100) of AUDITOR'S Plat "A", of the Southwest Quarter of Section No. One (1) Township One hundred six (106) North of Range No. Fourteen (14) West, more fully described as follows to wit:

Commencing at a point on the West boundary line of Section No. One (1) Township One hundred six (106) North of Range Fourteen West one hundred and eighty-eight and nine one-hundredths (188.09) Feet South and thirty-three (33) Feet East of the Northwest Corner of the Southwest Quarter, of the Southwest Quarter of said Section No. One (1) and running South parallel to said West boundary line four hundred thirty-six and three-tenths (436.3) Feet to the North line of Eleventh Street Southeast, thence East along the North line of Eleventh Street Southeast two hundred sixty-two (262) Feet to the West line of Fourth Avenue Southeast, thence North along the West line of Fourth Avenue Southeast four hundred thirty-six and twenty-three hundredths (436.23) Feet, thence West along the North boundary line of said Lot No. One hundred (100) two hundred sixty-two and two hundred fifty-two-thousandths (262.252) Feet to place of beginning.
