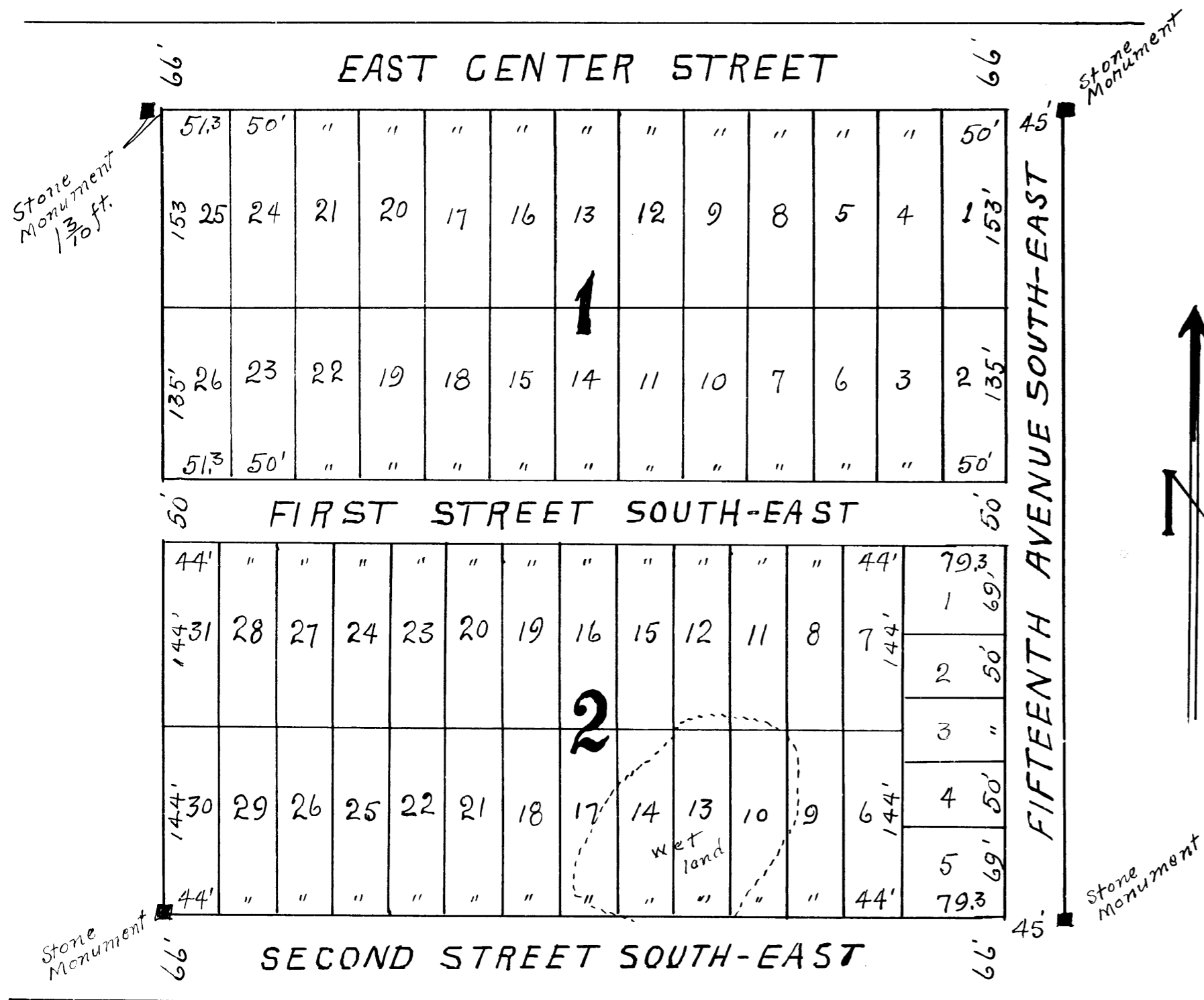


MAP OF THE HARVEY-SANDERSON ADDITION

I, Chas. H. Armstrong, Surveyor, do hereby certify that at the request of James F. Harvey and Mary J. Harvey husband and wife; Thomas E. Barber and Sadie B. Barber, husband and wife; S. O. Sanderson and Maude E. Sanderson, husband and wife; and Elizabeth Gilbert, single, owners of the following described tract or parcel of land, lying and being within the corporate limits of the City of Rochester, in the County of Olmsted and State of Minnesota, to-wit:— Commencing at the intersection of the East line of Lot Sixty (60) of State Sub-division of Section 36 Township 107, North, Range 14, west, and the north line of Second Street South-East (formerly known as Winona Road), for a place of beginning; running thence west along the north line of said Second Street South-East, 696³/₁₀ feet; thence north 626 feet to the south line of East Center Street (formerly East Fifth St.); thence east along the south line of said East Center Street 696³/₁₀ feet to the east line of said Lot 60; thence south along the east line of said Lot 60, 626 feet to place of beginning, I have surveyed and platted the said land into Blocks, Lots, Streets, and Avenues, as an Addition to the City of Rochester as shown on the accompanying Plat, said Addition to be known and designated as "THE HARVEY-SANDERSON ADDITION" to the City of Rochester. And I further certify that the said Plat is a correct representation of the survey; that all distances are correctly shown on the Plat as designated in feet and decimals of feet; that the monuments for guidance of future surveys have been correctly placed in the ground as shown thus ■; that the outside boundary lines are correctly designated on the Plat; that there are no wet lands thereon except that designated, and that said tract of land has not heretofore been platted into Blocks and Lots, except as a State Sub-division of said section 36.

Sanderson, husband and wife; and Elizabeth Gilbert, single, do hereby certify that we are the owners of the following described tract or parcel of land situated and being within the corporate limits of the City of Rochester in the County of Olmsted and State of Minnesota to-wit:— Commencing at the intersection of the east line of Lot Sixty (60) of State Sub-division of Section 36 Township 107, North, Range 14, west, and the north line of Second Street South-east, (formerly known as Winona Road), for a place of beginning; running thence West along the north line of said Second Street South-east 696³/₁₀ feet; thence north 626 feet to the south line of East Center Street, (formerly East Fifth Street); thence east along the south line of said East Center Street 696³/₁₀ feet to the east line of said Lot 60; thence south along the east line of said Lot 60, 626 feet to place of beginning.

And we further certify that we have caused the same to be surveyed and platted into Blocks, Lots, Streets and Avenues as an Addition to the City of Rochester to be known and designated as "THE HARVEY-SANDERSON ADDITION" and that we do for ourselves, our heirs and assigns hereby grant and dedicate the Streets and Avenues as laid down on the accompanying Plat to the City of Rochester and for the public use as such forever.
