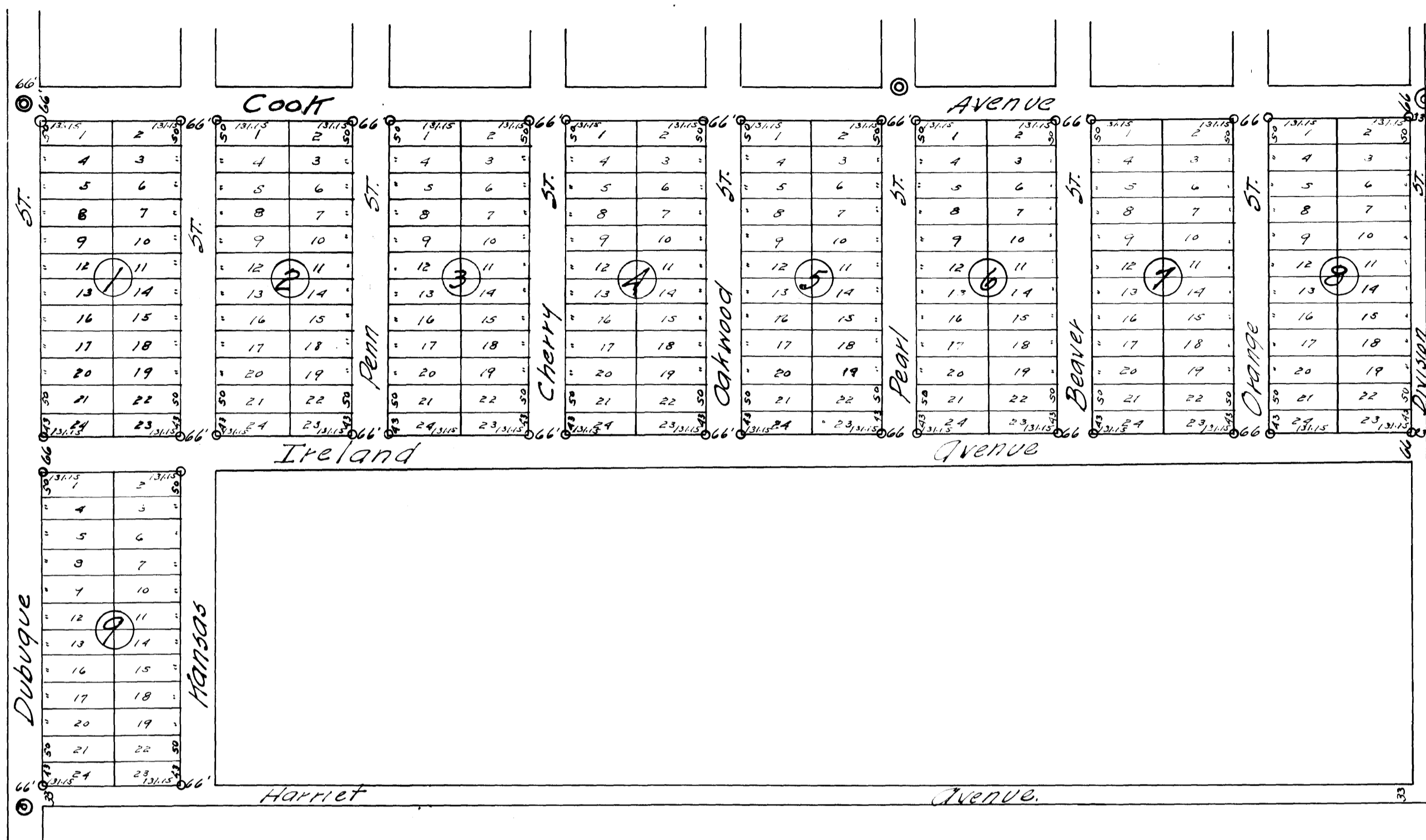


IRELAND'S 1ST ADDITION.

I, J. C. Utton, do hereby certify that at the request of W. W. Ireland and Annie E. Ireland, his wife, owners of the following described tract or parcel of land, lying and being within the corporate limits of the City of Rochester, County of Olmsted, State of Minnesota, to-wit: Part of the North one half (1/2) of the North West one quarter (1/4) of Section Twelve (12) Township One hundred six (106) N. of Range Fourteen (14) W. I have surveyed and platted said tract or parcel of land above described into Blocks, Lots and Streets, as an Addition to the City of Rochester, as shown on the accompanying Plat, said Addition to be known and designated as "Ireland's 1st Addition." I further certify that the accompanying Plat is a true and correct representation of the survey, that all the distances are correctly shown on plat in feet and decimals of a foot, that monuments for guidance of future surveys have been placed as shown thus © that the outside boundary lines are correctly designated on the plat, that there are no wet lands thereon and that said tract of land has not been heretofore platted into Blocks and Lots.
