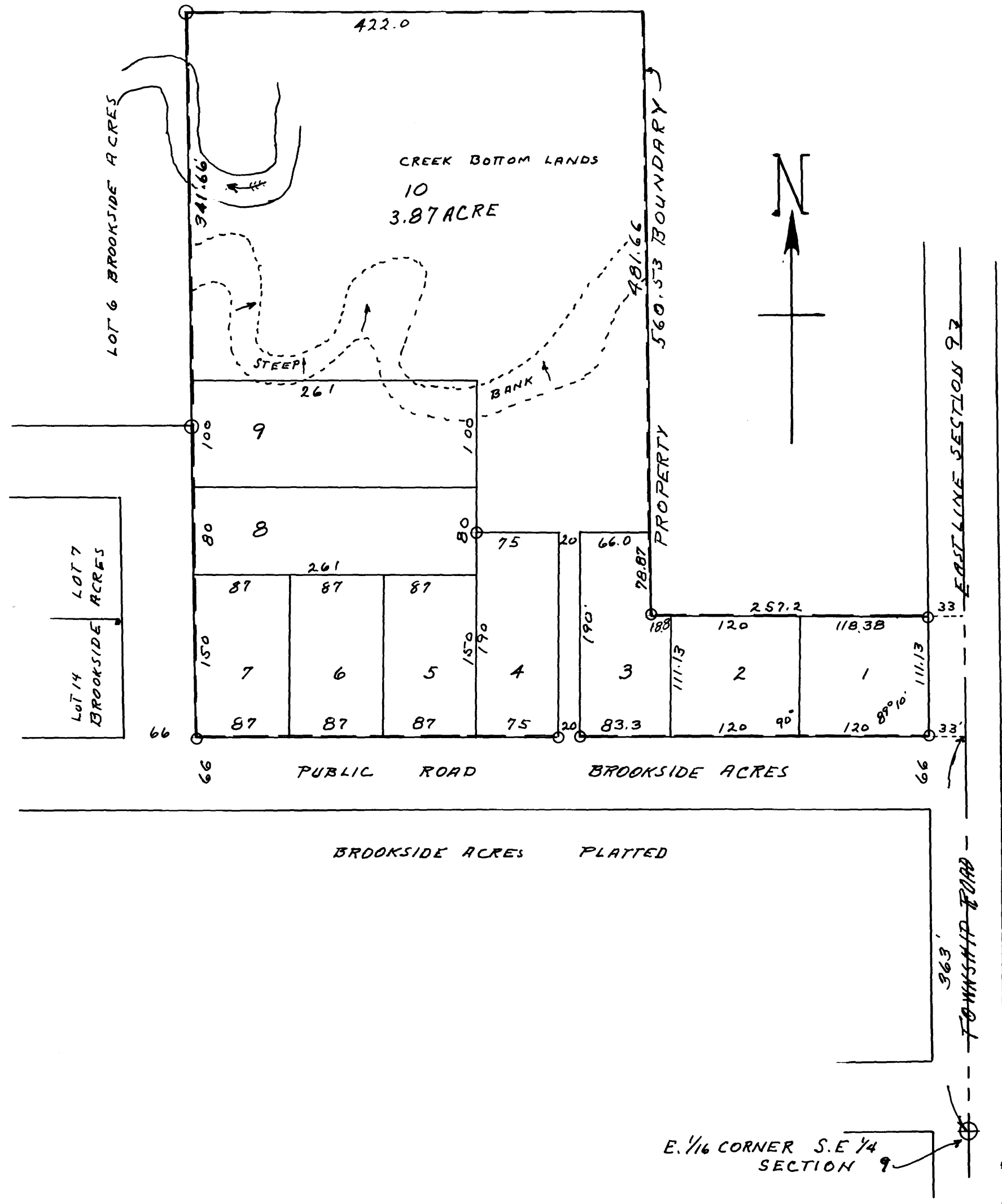


BRUMM'S ADDITION TO BROOKSIDE ACRES.

I, JOHN J. KERR COUNTY SURVEYOR IN AND FOR SAID COUNTY DO HEREBY CERTIFY THAT AT THE REQUEST OF GEORGE B. BRUMM AND MARCIA F. BRUMM (HIS WIFE) OWNERS OF THE FOLLOWING DESCRIBED LANDS TO-WIT: COMMENCING AT THE NORTHEAST CORNER OF LOT 6 BROOKSIDE ACRES, A SUBDIVISION IN THE NORTHEAST 1/4 OF THE SOUTHEAST 1/4 OF SECTION 9, TOWNSHIP 106 NORTH OF RANGE 13 WEST, AND RUNNING THENCE EAST 422 FEET, THENCE SOUTH 560.33 FEET, THENCE EAST PARALLEL WITH THE NORTH LINES OF LOTS 20 THROUGH 26 OF BROOKSIDE ACRES TO THE EAST LINE OF SAID SECTION, THENCE SOUTH ALONG THE EAST LINE OF SAID SECTION 111.13 FEET TO THE NORTH LINE OF A PUBLIC ROAD IN BROOKSIDE ACRES, THENCE WEST ALONG THE NORTH LINE OF SAID ROAD TO A POINT WHICH IS 66 FEET EAST OF THE SOUTHEAST CORNER OF LOT 14, BROOKSIDE ACRES, THENCE NORTH 671.66 FEET TO THE PLACE OF BEGINNING, I HAVE SURVEYED AND PLATTED SAID LANDS INTO LOTS AND A PUBLIC ROAD SUCH SUBDIVISION TO BE KNOWN AND DESIGNATED AS "BRUMM'S ADDITION TO BROOKSIDE ACRES", I FURTHER CERTIFY THAT THE ACCOMPANYING PLAT IS A TRUE REPRESENTATION OF SAID SURVEY AS MADE, THAT MONUMENTS FOR THE GUIDANCE OF FUTURE SURVEYS HAVE BEEN PLACED IN THE GROUND AT THE LOCATIONS MARKED THUS ●, THAT THERE ARE SOME WET LANDS THEREON AS SHOWN ON SAID PLAT, THAT SAID LANDS HAVE NOT HERETOFORE BEEN SUBDIVIDED, THAT ANGLES OF ENCLOSURE ARE SHOWN ON SAID PLAT.
