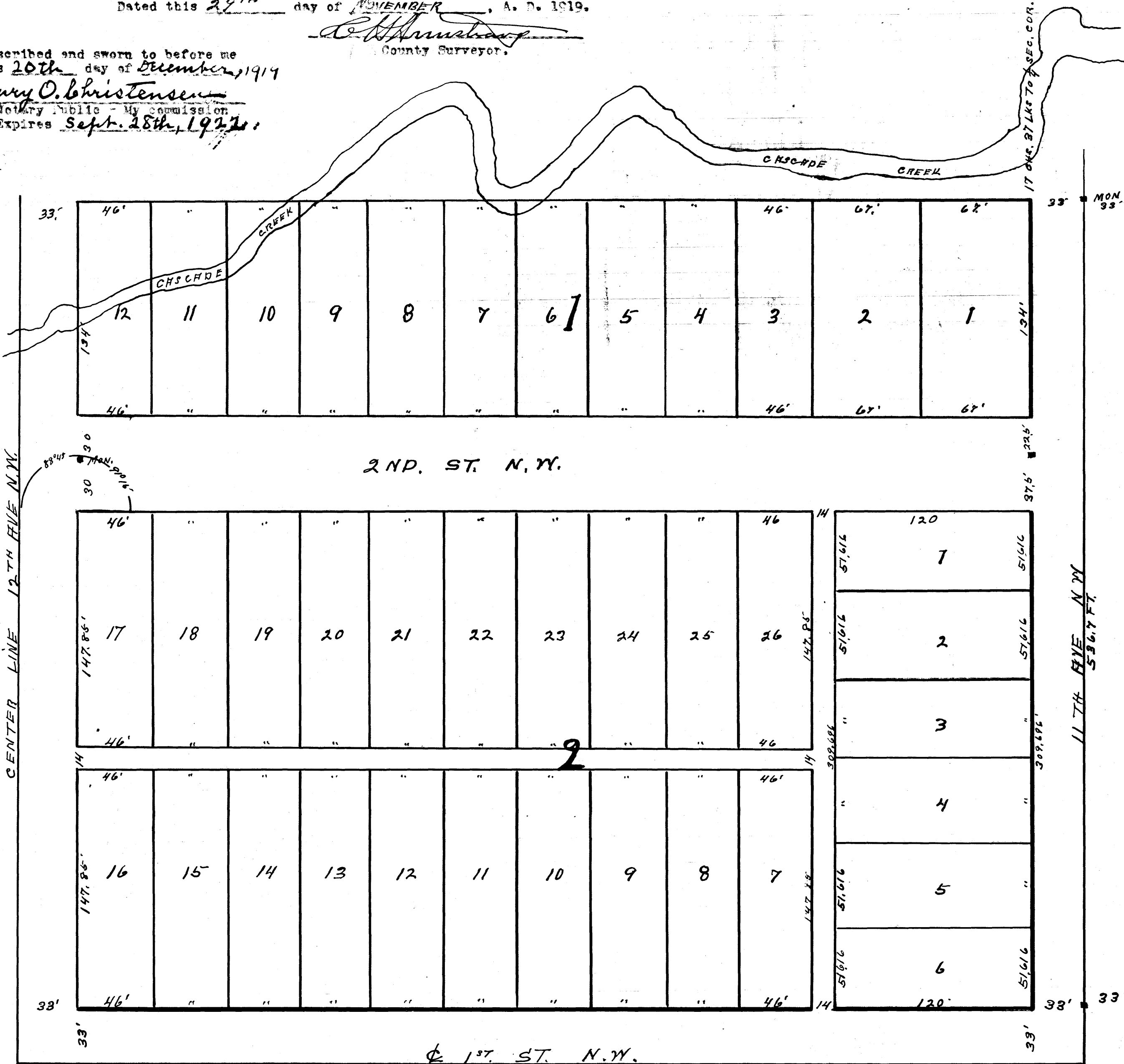
Commencing thirty three (33) feet east and thirty three (33) feet north of the northeast corner of lot five (5) in Block one (1) of Kutsky's Second Addition to the City of Rochester, being a point on the section line nine hundred ninety and eight tenths (990.8) feet north to the southeast corner of Section thirty four (34) in Township one hundred seven (107) north of Range fourteen (14) west, running thence west forty (40) rods, thence north five hundred thirty six and seven tenths (536.7) feet, thence east forty (40) rods, to a point on the section line seventeen (17) chains and thirty seven (37) links south from the northeast corner of the Southeast quarter (1/4) of said Section thirty four (34), thence south five hundred thirty six and seven tenths (536.7) feet to the place of beginning, I have surveyed and platted the said land into blocks, lots, streets, avenues and alleys as an Addition to the City of Rochester as shown on the accompanying plat, said Addition to be known and designated as Louisa Reiter's Addition to the City of Rochester.
