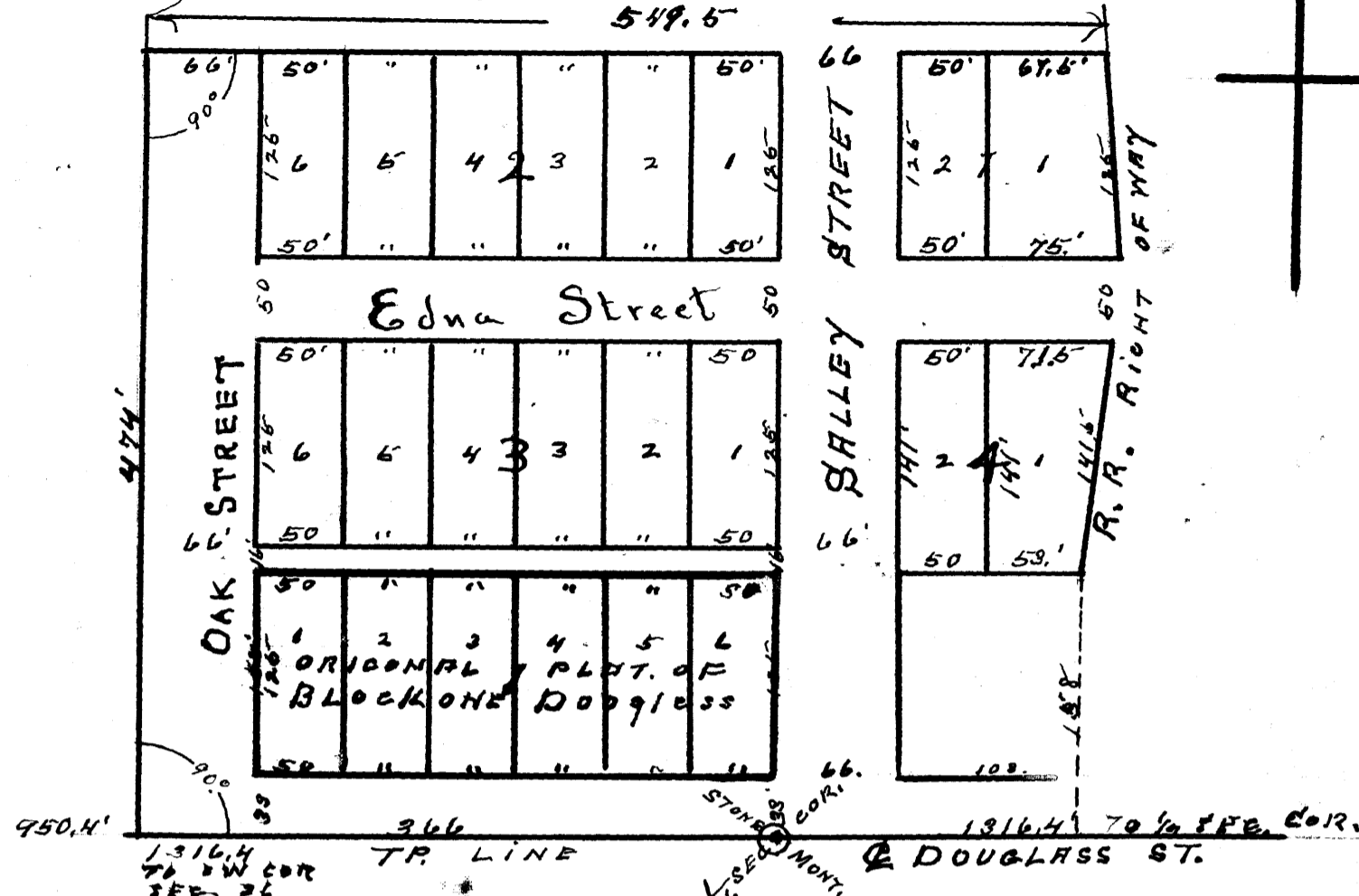


**PLAT OF SALLEY'S ADDITION TO DOUGLASS**

I, C. W. ARMSTRONG, County Surveyor in and for said County, do hereby certify that at the request of Clare Salley, Widower, John Fieck and Grace Fieck, Husband and wife, J. F. Koelch and BERTH Koelch, Husband and wife, Owners. I did Survey Plat and Layout into Lots, Blocks, Streets and Alleys. The following Described Lands to be known and designated as SALLEY'S ADDITION to Douglass.

Commencing at the North West Corner of Lot number One in Block Number One, in the Village of DOUGLASS Olmsted County Minn. and running South One Hundred and fifty eight feet to A point three hundred feet West of the one sixteenth section corner on the south Bdy. line of the South west one quarter of section thirty six Tp. one hundred and eight range fifteen. fifth P. M. Minn.

Thence running west on south Bdy. of said section Sixty Six feet. Thence running North four hundred and seventy four feet. thence running East five hundred and forty nine and one half feet, thence southerly along the west line of the right of way of the Chicago and Great Western Ry. Company to A point one hundred and fifty eight feet North of the South Bdy. of Section 36, thence West four hundred and sixty nine feet to place of beginning. All being and lying within the south one half of the south west one quarter of section thirty six. Tp. one hundred and eight north of Range fifteen west in Olmsted County Minnesota.

I further certify that the annexed Plat is a true and Correct Record of the Survey as Made that the distances are as shown in feet and decimals of feet. That the monuments for the guidance of future surveys are as shown on the annexed Plat marked thus (C). That there are no wet lands embraced within the Plat. That the said lands have never before been Platted, as an ADDITION to the Village of DOUGLASS.

Commencing at the North West Corner of Lot number One in Block Number ONE in the Village of Douglass, Olmsted County Minn. and running South One Hundred and fifty eight feet, to A point three hundred feet west of the south east corner of the south west one quarter of the south west one quarter section thirty six. Tp. 108 N. R. 15 W. Thence running west on south Bdy. of section thirty six, sixty six (66) feet Thence running North four hundred and seventy four (474) feet. Thence running East five hundred and forty nine and one half (549.5) feet, to the west line of right of way of the Chicago and Great Western Ry. Company, Thence running in a southerly direction, along the West line of said right of way, to A point one hundred and fifty eight (158) feet north of the south Bdy. of Sec. Thence running west four hundred and sixty nine (469) feet, to Place of Beginning.
