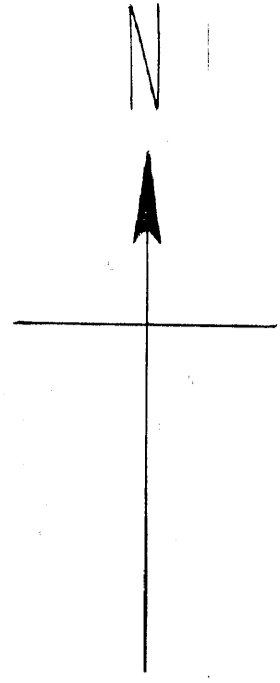


HOLM'S SUB-DIVISION.

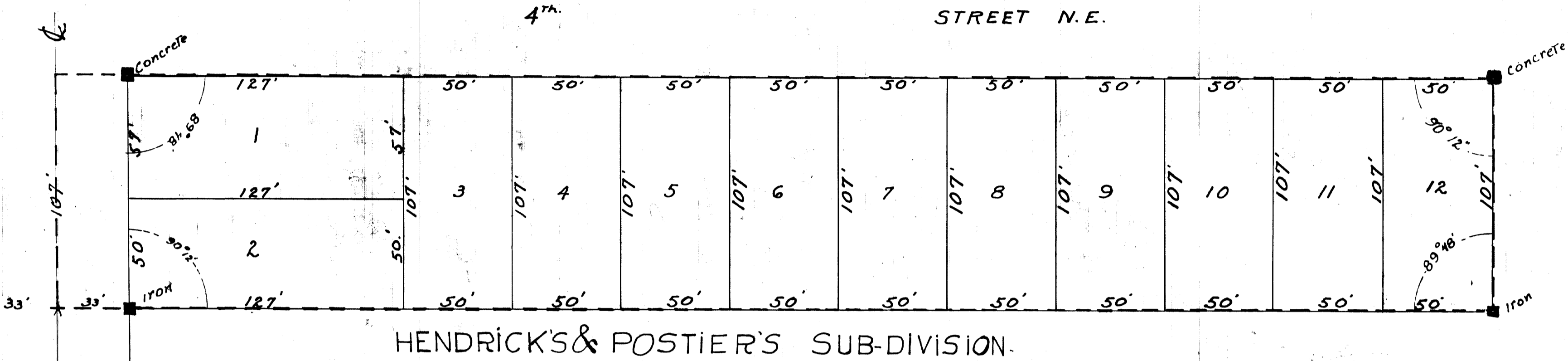
OF A PART OF LOTS 45 & 46 SCHOOL SECTION 36

SURVEYORS CERTIFICATE

I JOHN J. KERR, SURVEYOR, do hereby certify that at the request of NELS HOLM and JULIA HOLM his wife owners of the following described tract of land to-wit:

Commencing at a point on the west line of lot forty-five (45) in the State Sub-division of section thirty-six (36) in Township one hundred and seven (107) North of Range fourteen (14) West, sixteen (16) rods north of the southwest corner of said lot forty-five (45) running thence east parallel with the south line of said lot a distance of forty (40) rods, running thence north one hundred and seven (107) feet, running thence west and parallel with the south line of said lot a distance of forty (40) rods, running thence south with the west line of said lot forty-five (45) a distance of one hundred and seven (107) feet to the place of beginning, I have surveyed the above described lands into lots and streets as shown on the accompanying plat, said plat to be known and designated as "HOLM'S SUB-DIVISION";
