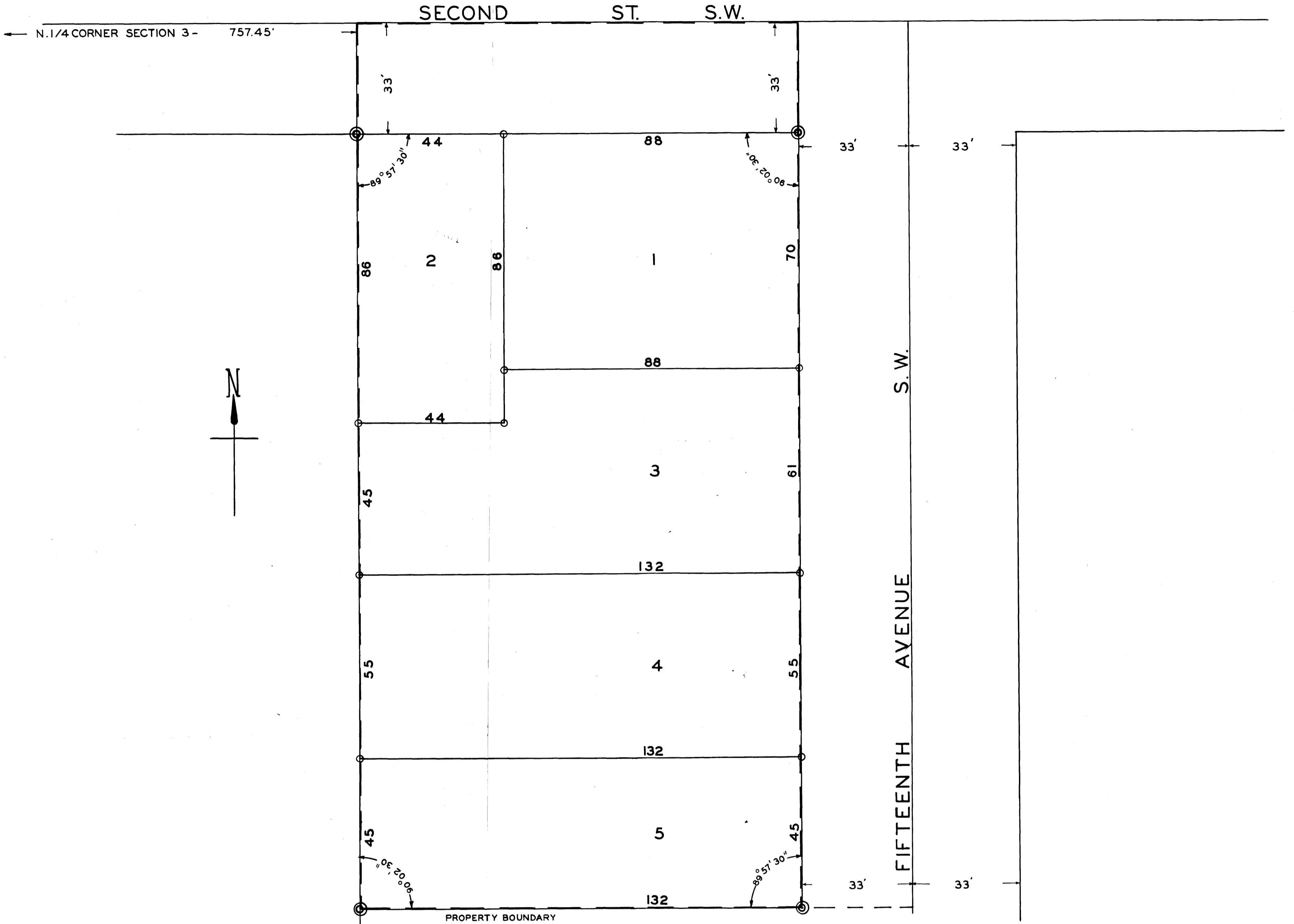


RIEGE'S ADDITION.

I JOHN J. KERR COUNTY SURVEYOR, DO HEREBY CERTIFY, THAT AT THE REQUEST OF WALTER T. RIEGE AND NINA MAY RIEGE HIS WIFE, OWNERS OF THE REAL ESTATE IN THE COUNTY OF OLMSTED, STATE OF MINNESOTA, AS HEREINAFTER DESCRIBED TO WIT: THE WEST ONE (1) ACRE, OF THE NORTH TWO (2) ACRES, OF THE EAST TEN (10) ACRES, OF THE WEST THIRTY THREE (33) ACRES, OF THE NORTHWEST ONE QUARTER (1/4), OF THE NORTHEAST ONE QUARTER (1/4), OF SECTION NO. THREE (3), IN TOWNSHIP NO. ONE HUNDRED SIX (106), NORTH, OF RANGE, FOURTEEN (14) WEST OF THE FIFTH (5) PRINCIPAL MERIDIAN, EXCEPT THE EAST TWO (2) RODS THEREOF, I HAVE SURVEYED, STAKED, AND PLATTED THE SAID REAL ESTATE INTO LOTS AND STREETS AS SHOWN BY THE PLAT ON WHICH THIS CERTIFICATE IS WRITTEN AND WHICH SHALL BE KNOWN AND DESIGNATED AS "RIEGE'S ADDITION" I FURTHER CERTIFY, THAT THE PLAT IS A CORRECT REPRESENTATION OF SUCH SURVEY, THAT ALL DISTANCES ARE CORRECTLY SHOWN ON THE PLAT AS DESIGNATED IN FEET AND DECIMALS OF FEET, THAT THE OUTSIDE BOUNDARIES ARE CORRECTLY DESIGNATED ON THE PLAT, THAT THERE ARE NO WET LANDS TO BE DESIGNATED, THAT NO PART OF SAID TRACT OF LAND HAVE BEEN HERETOFORE PLATTED, AND THAT MONUMENTS FOR THE GUIDANCE OF FUTURE SURVEYS HAVE BEEN PLACED IN THE GROUND AT THE PLACES DESIGNATED THUS
