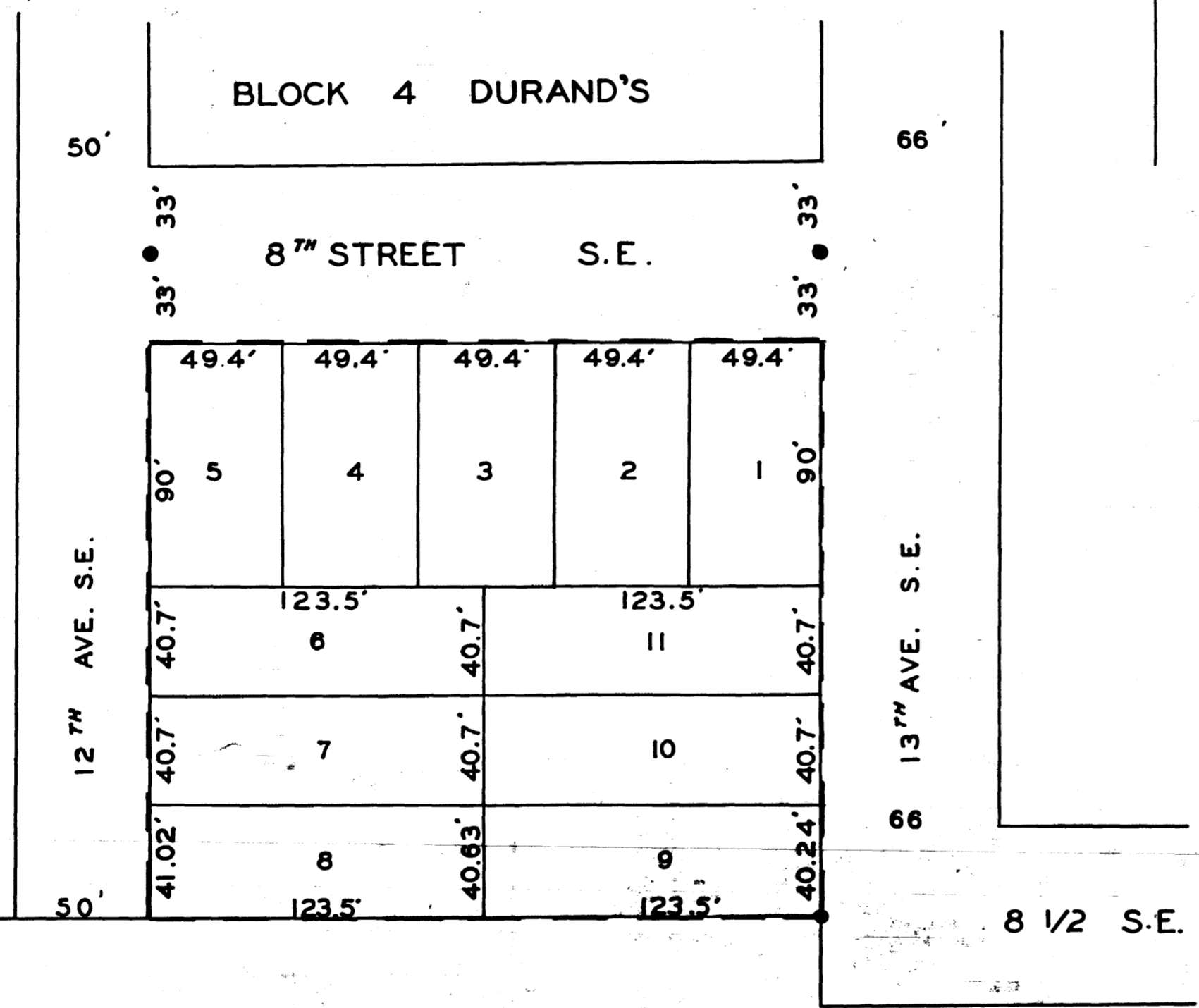


ARMIT'S REPLAT OF OUTLOT NUMBER TWO

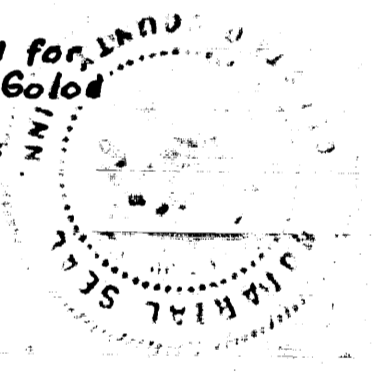

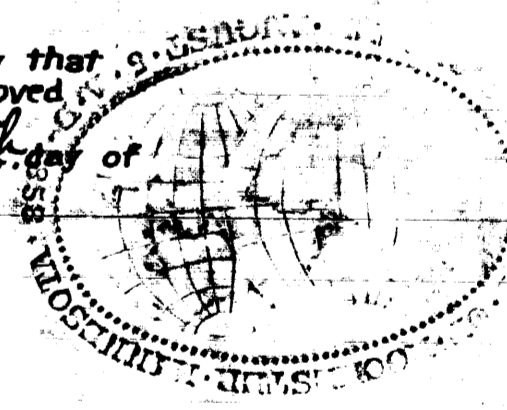
