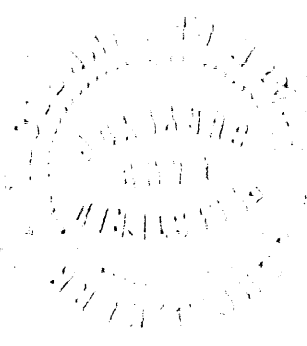

Gehlhar and Helena Gehlhar (his wife) owners of the following described lands to-wit; Commencing at the northeast corner of lot number thirty-six (36) in State Subdivision of School Section Thirtysix (36) Township one hundred seven (107) North of Range fourteen (14) west, in Olmsted County, Minnesota for a place of beginning and running thence west along the north line of said lot a distance of thirteen hundred twenty and four tenths (1320.4) feet to the northwest corner of said lot, Thence south along the west line of said lot sixtyone (61) feet, thence east parallel with the north line of said lot two hundred (200) feet, Thence south one hundred eighty nine (189) feet, Thence east parallel with the north line of said lot four hundred thirty (430) feet, Thence south eighty (80) feet, thence east six hundred ninety (690) feet to the east line of said lot, and running thence north along the east line of said lot three hundred thirty (330) feet to place of beginning. 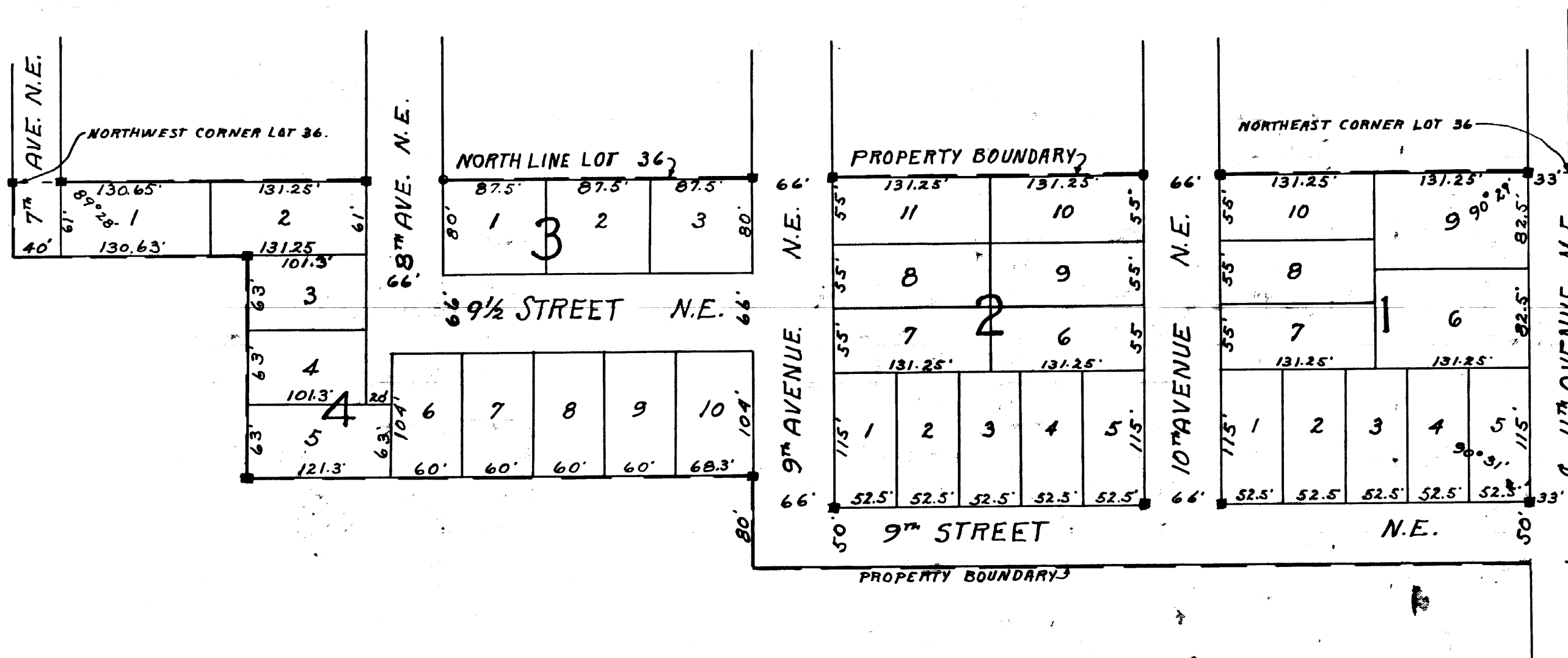
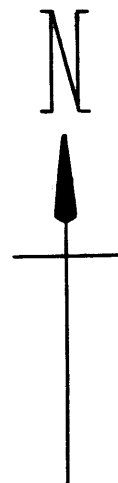
