I, John J. Kerr County Surveyor do hereby certify that at the request of Phillip H. Barck and Marie Barck (his wife), Robert Merz and Marie Merz (his wife), M. H. 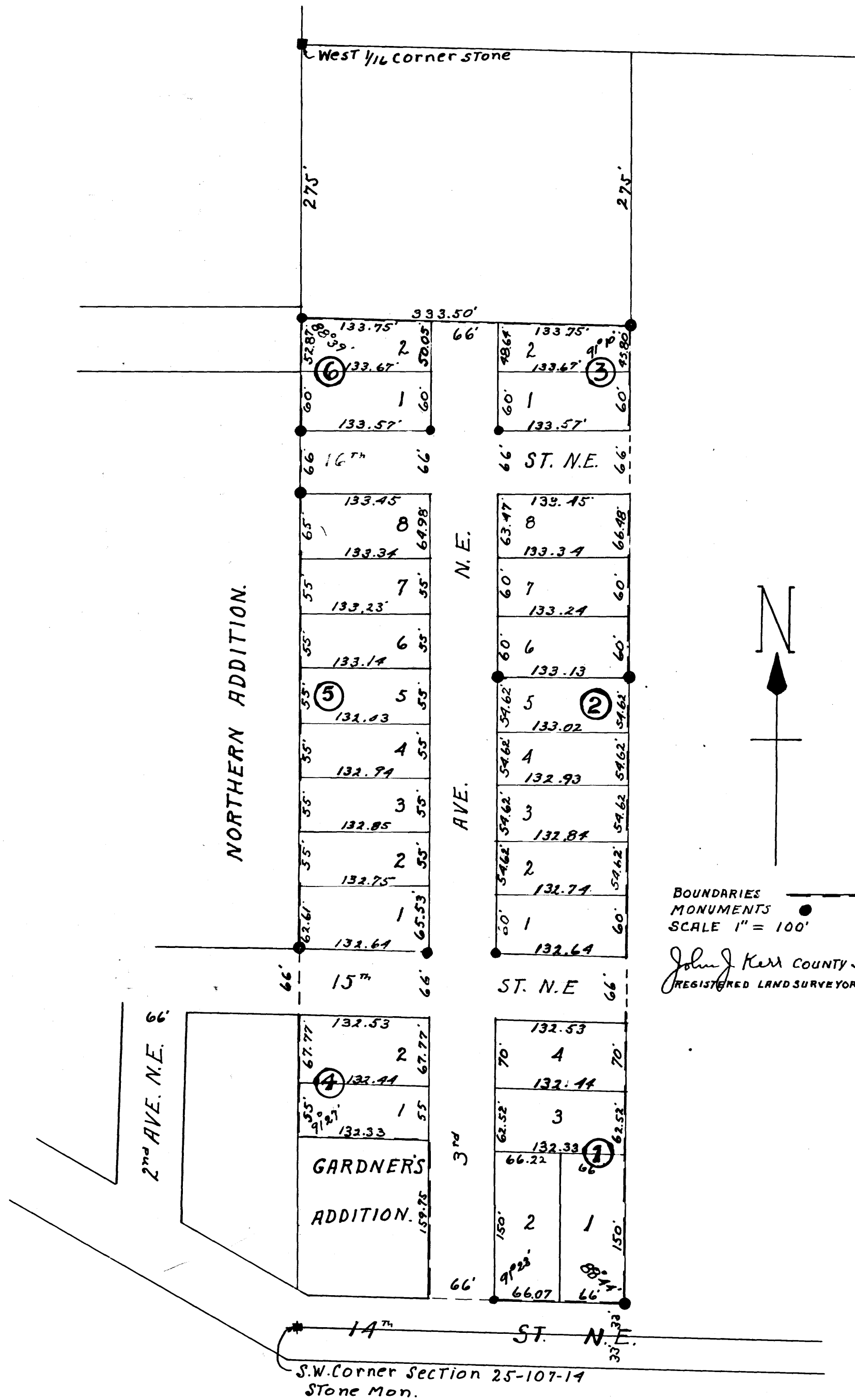
