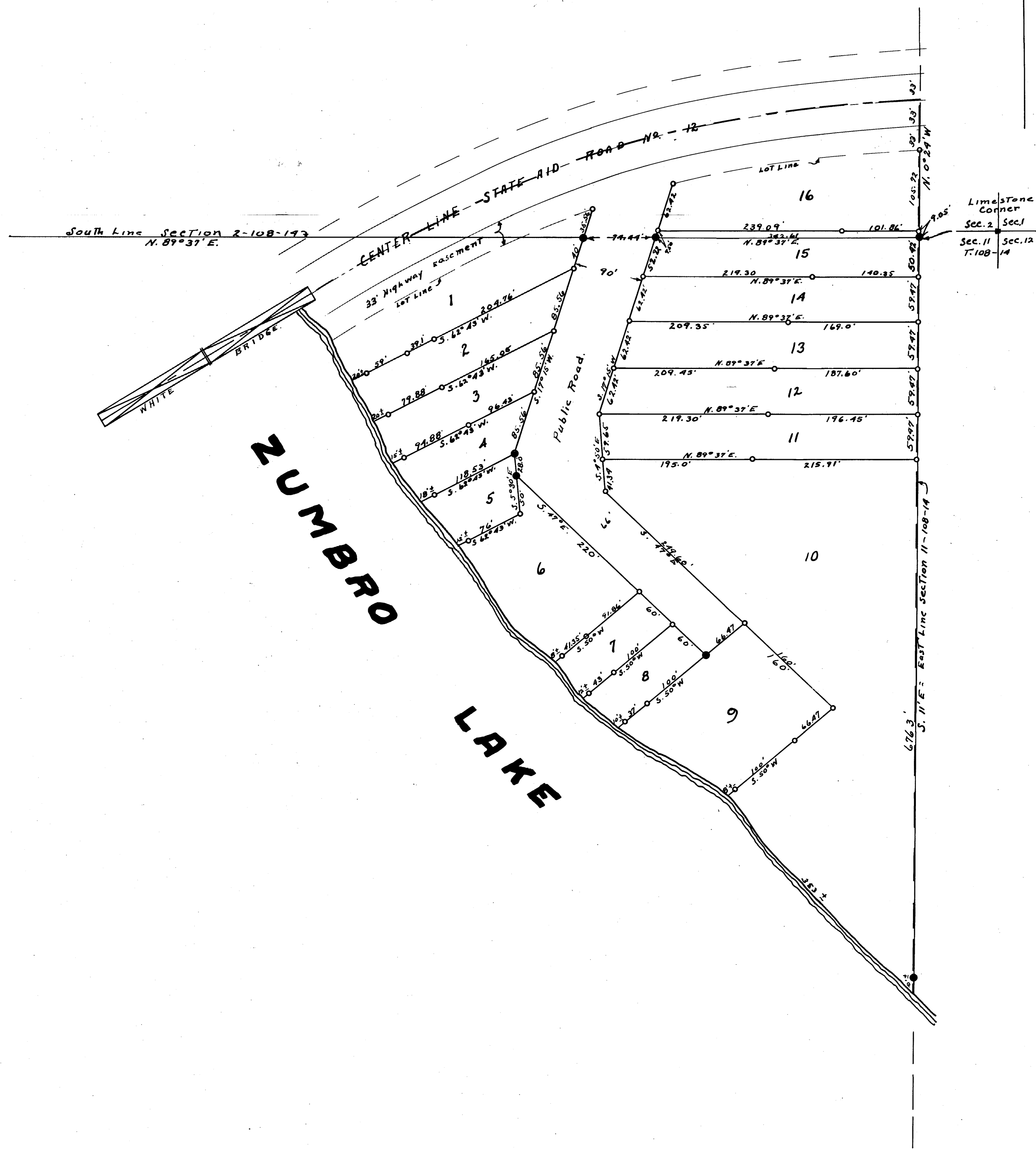


# "WHITE BRIDGE SUBDIVISION."

SURVEYORS' CERTIFICATE.  
I, John J. Kerr do hereby certify that at the request of Don W. Emerson and Lucile Emerson (his wife) Owners of the following described lands; Commencing at the Southeast Corner of Section two (2) Township one hundred eight (108) North of Range fourteen (14) west for a place of beginning and running thence north along the east line of said section one hundred eighty and seventy seven one hundredths (180.77) feet to the center line of State Aid Road number twelve (12), thence in a westerly direction along the center line of said road to the highwater mark of the new lake caused by the damming of the Zumbro River by the City of Rochester, for power purposes.
