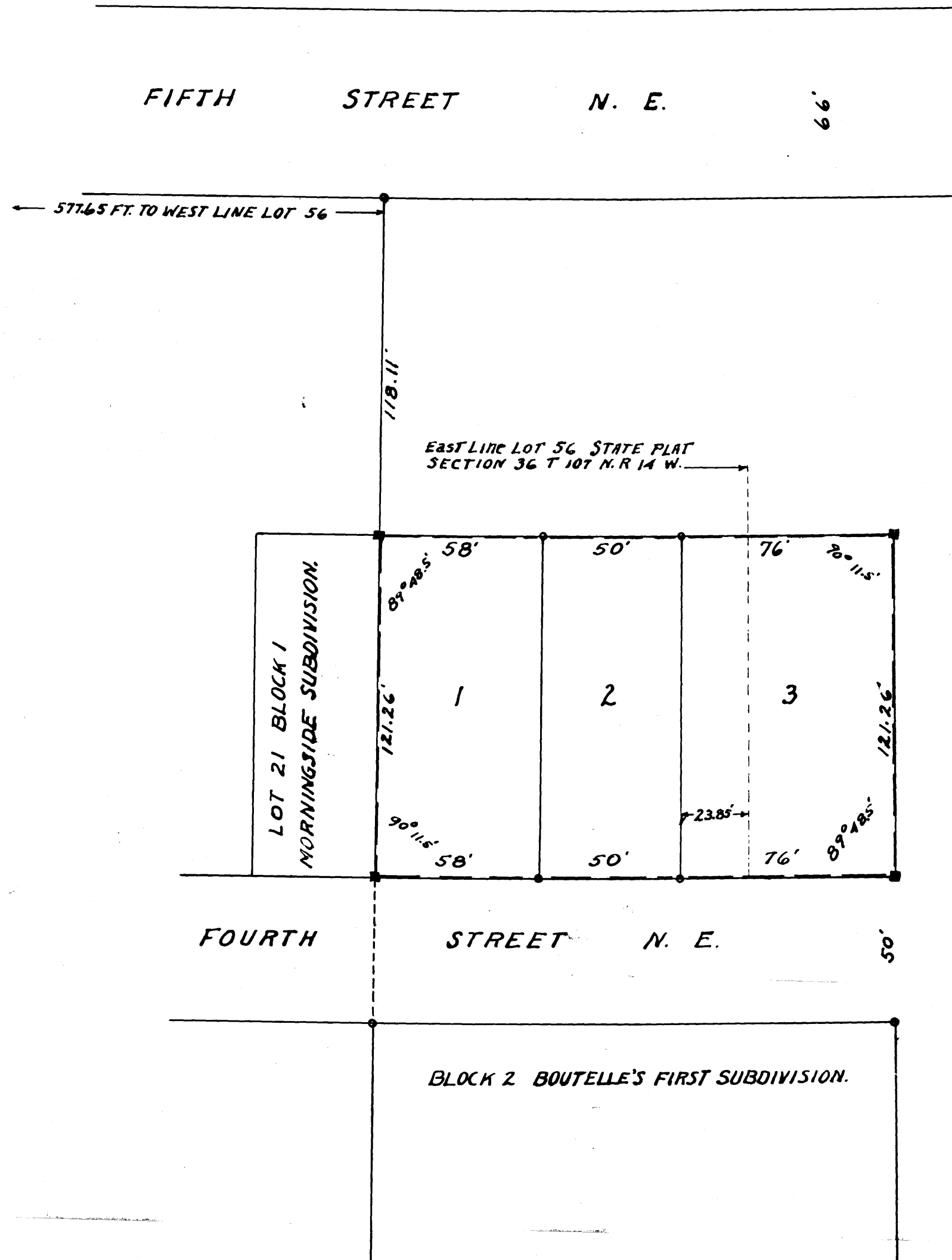


LOUISE'S ADDITION.

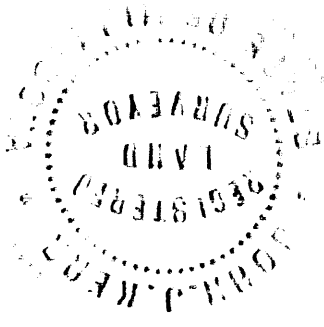
ROCHESTER MINNESOTA.

SURVEYORS CERTIFICATE.
