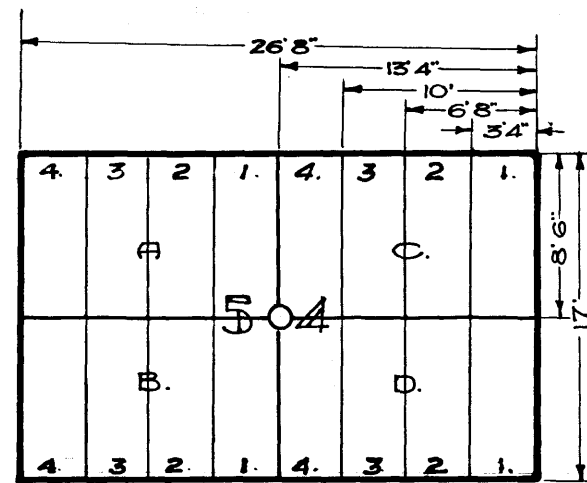


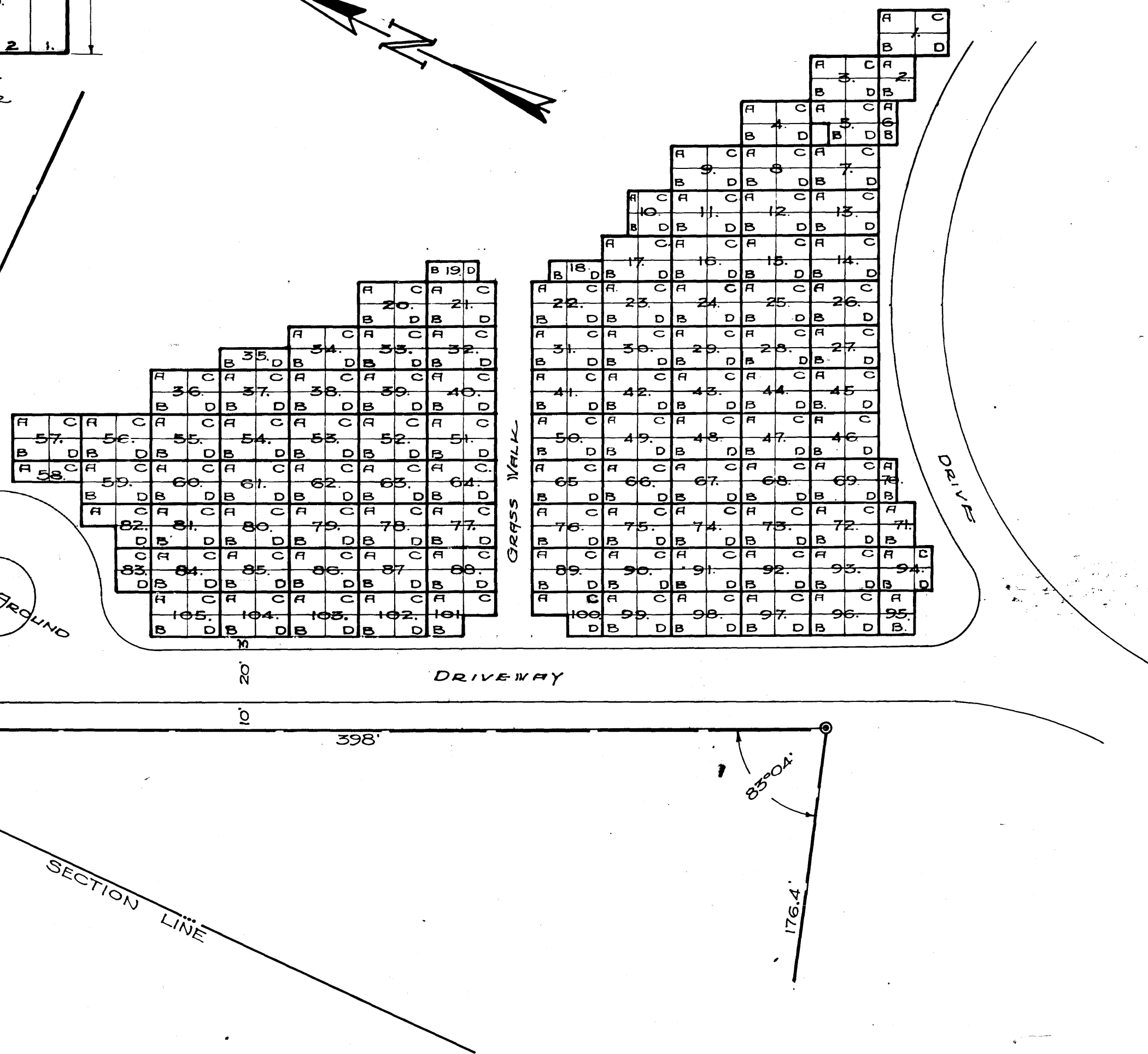
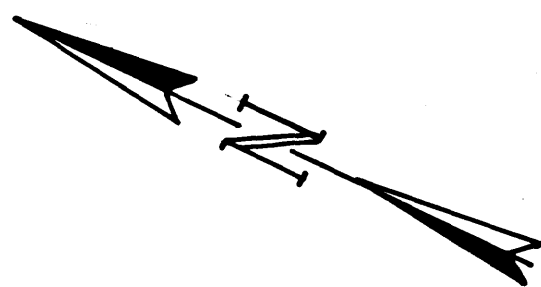

MARKER IN CENTER



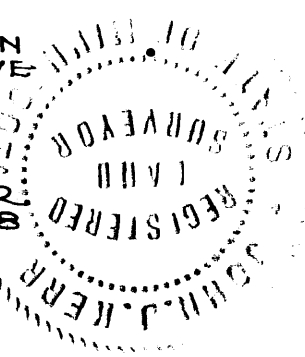
