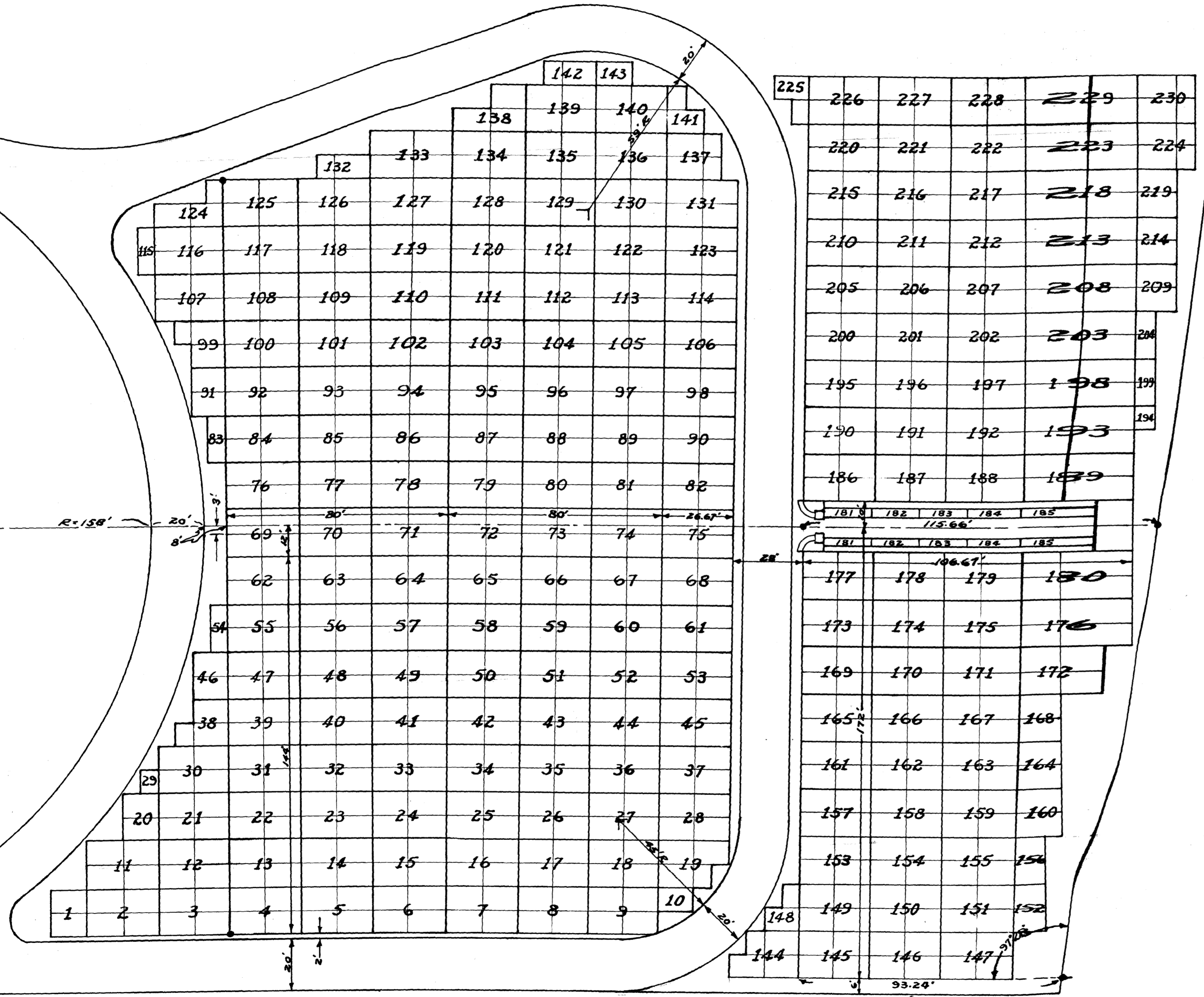
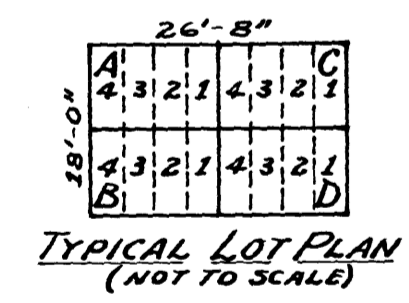
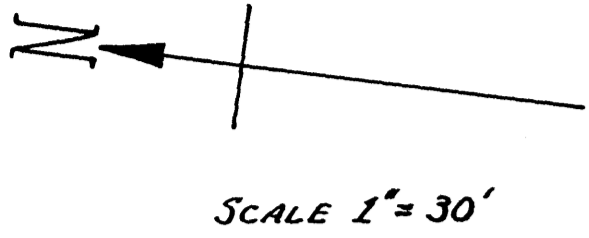


GARDEN OF THE GOOD SHEPHERD
