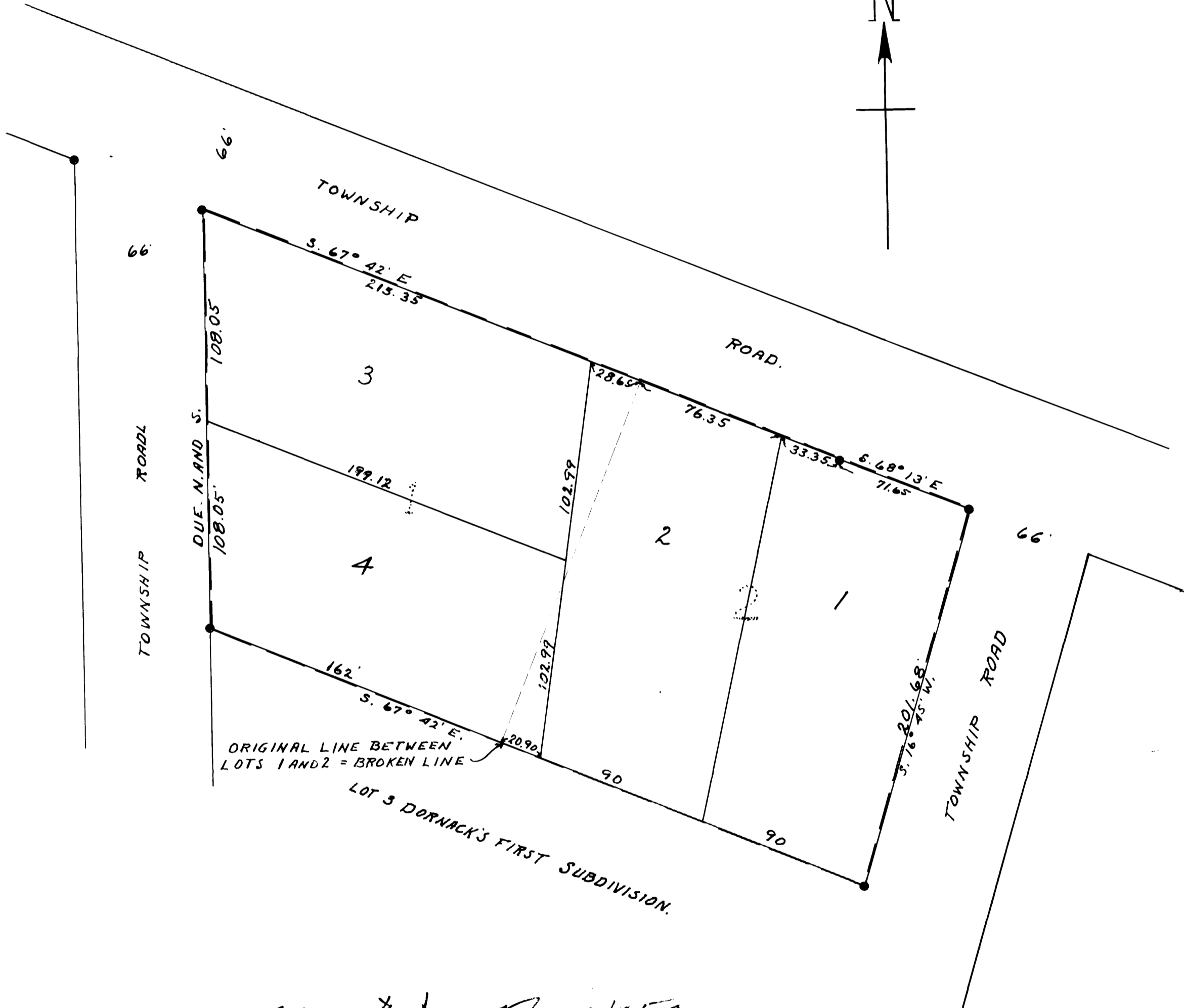
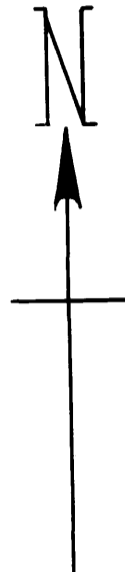
PROPERTY BOUNDARIES SHOWN THUS .
