SURVEYOR'S CERTIFICATE

I, K.M. McGhie, Registered Civil Engineer and Land Surveyor do hereby certify that the request of DONALD C. SPONG and EDNA M. SPONG, his wife, I have surveyed and plotted into lots, as shown on the accompanying plat in which this certificate is written and which shall be known and designated as **KNOLLVIEW ADDITION**, the following described tract of land:

A part of the North half of the Southwest quarter of Section 6, Township 107 North Range 13 West described by metes and bounds as follows:

Beginning at the Southwest corner of the North half of said Southwest quarter, running thence North along the West line of said Southwest quarter for a distance of 611.1 feet, thence Southeasterly at a deflection angle of 121 degrees 23 minutes to the right for a distance of 316.5 feet to a point in the center line of State Trunk Highway No. 63, thence Southwesterly along the center line of said Trunk Highway for a distance of 487.2 feet, to the point where said center line crosses the South line of the North half of said Southwest quarter, thence West on said South line to the place of beginning.

And I further certify that the said plat is a true and correct record of the survey and that all distances are correctly shown in feet and decimals of feet, that monuments (iron pins) for the guidance of future surveys have been placed on the ground as shown thus (o), that the outside boundaries are correctly shown on the plat, that there are no wet lands thereon and that said plat has not been previously plotted.

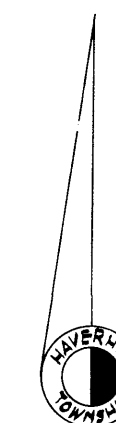
