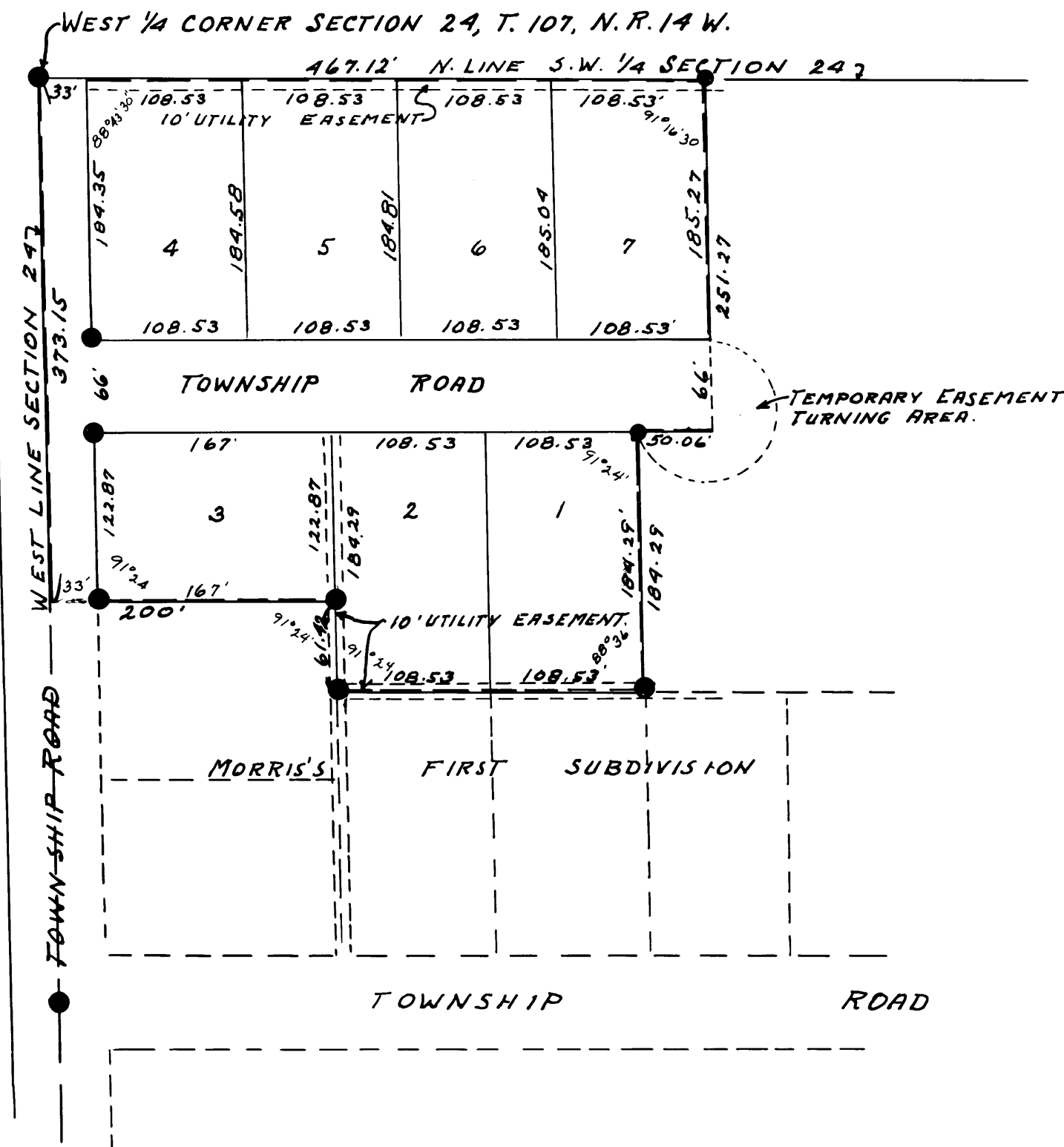


# MORRIS'S SECOND SUBDIVISION.

## SURVEYORS CERTIFICATE.

 I, JOHN J. KERR COUNTY SURVEYOR IN AND FOR SAID COUNTY DO HEREBY CERTIFY THAT AT THE REQUEST OF  
 ARTHUR E. MORRIS AND EMMA H. MORRIS (HIS WIFE) OWNERS OF THE FOLLOWING DESCRIBED LANDS TO-WIT:  
 COMMENCING AT THE NORTHWEST CORNER OF THE SOUTHWEST 1/4 OF SECTION 24, TOWNSHIP 107, NORTH OF  
 RANGE 14 WEST AND RUNNING THENCE EAST ALONG THE NORTH LINE OF SAID SOUTHWEST 1/4 A DISTANCE OF  
 467.12 FEET, THENCE SOUTH PARALLEL WITH THE WEST LINE OF SAID SECTION 251.27 FEET, THENCE WEST  
 467.12 FEET, THENCE SOUTH PARALLEL WITH THE WEST LINE OF SAID WEST LINE 184.29 FEET, THENCE WEST A DISTANCE OF  
 50.06 FEET, THENCE SOUTH PARALLEL WITH SAID WEST LINE 184.29 FEET, THENCE WEST A DISTANCE OF  
 217.06 FEET, THENCE NORTH PARALLEL WITH SAID WEST LINE A DISTANCE OF 61.42 FEET, THENCE WEST  
 A DISTANCE OF 200 FEET TO THE WEST LINE OF SAID SECTION, THENCE NORTH ALONG THE WEST LINE OF  
 SAID SECTION A DISTANCE OF 373.15 FEET TO THE PLACE OF BEGINNING, I HAVE SURVEYED AND PLATTED  
 SAID LANDS INTO LOTS AND PUBLIC ROADS SUCH SUBDIVISION TO BE KNOWN AND DESIGNATED AS  
 "MORRIS'S SECOND SUBDIVISION", I FURTHER CERTIFY THAT THE ACCOMPANYING PLAT IS A TRUE  
 REPRESENTATION OF SAID SURVEY AS MADE, THAT THE LENGTHS OF ALL LINES ARE SHOWN IN FEET AND  
 DECIMALS OF A FOOT, THAT MONUMENTS FOR THE GUIDANCE OF FUTURE SURVEYS HAVE BEEN PLACED IN THE  
 GROUND AT THE LOCATIONS MARKED THUS, THAT SAID LANDS HAVE NOT HERE-TO-FORE BEEN PLATTED,
